

Please recall earlier letter DO No.1(276)/Grv/11-12/CD/863 dated 3<sup>rd</sup> April 2012 on the subject mentioned above. Now, some similar cases have come to the notice of this office through Office of the Chief Commissioner for Persons with Disabilities regarding recruitment of Senior/Junior residents/ Medical officer in various hospitals, as per photocopy enclosed. Here also there is no clear indication of the posts reserved for persons with disabilities. These hospitals are Pt. Madan Mohan Malviya Hospital, Babu Jagjivan Ram Memorial Hospital, Rajiv Gandhi Super Specialty Hospital, Sardar Vallabh Bhai Patel Hospital, Dr.Baba Saheb Ambedkar Hospital, Guru Govind Singh Govt. Hospital, G.B.Pant Hospital, Maulana Azad Medical College, Maharishi Valmiki Hospital, Satyawadi Raja Harish Chandra Hospital, Bhagwan Mahavir Hospital, Dr.Hedgewar Arogya Sansthan, Acharya Shree Bhikshu Government Hospital, Sanjay Gandhi Memorial Hospital, Chacha Nehru Bal Chikitsalya, Deen Dayal Upadhyay Hospital, Rao Tula Ram Memorial Hospital, Dr.N.C.Joshi Memorial Hospital, Sushruta Trauma Centre and Institute of Liver & Biliary Sciences, New Delhi.

In these cases also I would request that instructions may be issued to all hospitals of the Health Department so that such flawed advertisements are not issued. In addition, the hospitals may be asked to immediately keep aside the necessary vacancies and to issue fresh advertisement specifying posts for persons with disabilities.

Kindly let us know the action taken and the outcome.
