Hospital, G.B.Pant Hospital, Maulana Azad Medical College, Maharishi Valmiki Hospital, Satyawadi Raja Harish Chandra Hospital, Bhagwan Mahavir Hospital. Dr.Hedgewar Arogya Sansthan, Acharya Shree Bhikshu Government Hospital, Sanjay Gandhi Memorial Hospital, Chacha Nehru Bal Chikitsalya, Deen Dayal Upadhyay Hospital, Rao Tula Ram Memorial Hospital, Dr.N.C.Joshi Memorial Hospital, Sushruta Trauma Centre and Institute of Liver & Biliary Sciences, New Delhi.

In these cases also I would request that instructions may be issued to all hospitals of the Health Department so that such flawed advertisements are not issued. 


