

4. All the Pay Levels/Grade Pays should be maintained as per 7<sup>th</sup> CPC.
5. If there is any contradiction in the Pay level/Grade Pay of the posts, then it may be treated as per their RRs.
6. The Outsourced posts should be paid as per norms of minimum wages.
