Subject: - Regarding One Time Regularization Policy through relaxation in age to the contractual Paramedical employees working in various Hospitals/Medical Institutions under H&FW Department, GNCTD.

Pursuant to the directions dated 26.11.2013 passed by the Hon'ble High Court, Delhi in CWP no. 6798/2002 titled Sonia Gandhi & Ors vs GNCTD & Ors, the Health and Family Welfare Department, Govt. of NCT of Delhi had issued O.M. dated 11.10.2020, framing a One Time Regularization Policy whereby one time age relaxation has been accorded to all the contractual Paramedical employees working in various Hospitals/Medical Institutions under H&FW, GNCTD for applying at the time of regular appointment on Direct Recruitment basis through DSSSB. Contractual paramedical employees hired against regular posts will be given age relaxation as per the following modalities: -

- (i) The Contractual Paramedical employees who were working as contractual employees under H&FW as on 26.11.2013 (date of order passed by Hon'ble High Court in WPC-6798/2002) and as on date are still continuing (as per extension given for year 2023-24) their service as contractual employee under H&FW Department are eligible for this age relaxation.
- (ii) The contractual employees should have worked at least 180 days in a particular year.
- (iii) The contractual employees under H&FW can apply only one time (without any age bar) in direct recruitment of their respective posts as per notification issued by DSSSB for regular appointment on direct recruitment basis.
- (iv) Only those contractual employees who were employed (at the time of their appointment on contractual basis) against regular sanctioned posts under H&FW Department are eligible for this relaxation.

In this context, it is brought to attention of all concerned that the DSSSB has notified the advertisement no.04/2024 dated 12.01.2024 for the post of Pharmacist vide post Code 01/24 under H&FW Department, Govt. of NCT of Delhi (copy enclosed).

All concerned contractual Paramedical employees are accordingly directed to apply against the advertisement issued by DSSSB using the one-time age relaxation given by the Competent Authority, failing which they shall loose the right for being considered for regularization as per the approved one-time regularization policy.

All concerned HODS are directed to bring the content of this Circular to notice of all concerned contractual employees with proper record, failing which they shall be personally held responsible for any lapse or future court case.

This issues with the prior approval of Competent Authority.
