The identified private hospitals, which were allotted land at concessional rates by land owning agencies and are providing COVID related treatment, shall earmark 10% of the total hospital bed capacity for free treatment (COVID & non COVID) as the case may be for treatment of eligible patients of EWS category.



Further, in case any hospital earmarks/ reserves more than 60% of its total bed capacity for COVID related treatment after the issuance of this corrigendum, the concerned hospital authorities are directed to inform the Supervising Authority in writing and seek clearance prior to operationalizing such COVID beds.
