NOTIFICATION

No. F.1(55)/Nursing/H&FW/2023- In exercise of the powers conferred under Article 309 of the Constitution, read with Government of India, Ministry of Home Affairs GSR No. 840 Dated 13th July 1959 and in supersession of all the previous notifications issued in this regard, except as respects things done or omitted to be done with UPSC, is pleased to make the following rules for regulating the method of recruitment to the post of Auxiliary Nurse Midwife in the Department of Health and Family Welfare, namely :-

1. Short title and commencement

(1) These rules may be called the Auxiliary Nurse Midwive's Recruitment Rules, 2022.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Number of posts, classification and scale of pay

The number of the said post, their classification and the scale of pay attached thereto shall be as specified in Schedule columns (2) to (4) of the Schedule annexed to these rules.

3. Method of Recruitment, age limit, qualification, etc.

The method of recruitment to the said post, age limit, qualification and other matters connected therewith, shall be as specified in columns (5) to (13) of the Schedule annexed to these rules.

4. Disqualification

No person shall be eligible for appointment to the Service.

(a) Who has entered into or contracted a marriage with a person having a spouse

living, or

(b) Who, having a spouse living, has entered into or contracted a marriage with any person. Provided that the Government may, if satisfied that such marriage is permissible underthe personal law applicable to such person and other party to the marriage and that there areother grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax

Where the Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, and in consultation with the Commission/Departments, relax any of the provisions of these rules with respect to any class or category of persons.

Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Other Backward Classes and other special categories of persons in accordance with the orders issued by the Government from time to time in this regard.
