- 1.2. The department also owns & operates colleges; hospitals and dispensaries in AYUSH Stream.
- 1.3. To manage and provide services the department has various types of equipments installed and used in health facilities.

2. Concept of Biomedical Equipment Maintenance Service

- 2.1 Biomedical equipment are medical devices and require calibration, maintenance, repair, user training, and decommissioning activities usually managed by Biomedical engineers.
- 2.2Medical equipment is used for the specific purposes of diagnosis and treatment of disease or rehabilitation following disease or injury; it can be used either alone or in combination with any accessory, consumable, or other piece of medical equipment.
- 2.3Medical equipment excludes implantable, disposable or single-use medical devices.
- 2.4 Medical Equipment have considerable Investments and it is important, therefore, to have a well-planned and managed maintenance programme that is able to keep the Medical equipment in a health-care institutions reliable, safe and available for use at all times.
- 2.5 A maintenance programme includes procedures for performance inspection, calibration/validation and preventive & breakdown maintenance.
- 2.6 With ever increasing Health care requirements for the people of Delhi, an efficient system of Biomedical Equipment Maintenance Services has to be established to ensure timely, safe and smooth provision of clinical services.

3. Scope of Biomedical Equipment Maintenance Services

<u>Key Components of Biomedical Equipment Maintenance Services include, but not limited to the following:</u>

- 3.1 Asset verification, mapping, tagging and inventory creation of all available biomedical equipments.
- 3.2 Corrective actions for existing problems including repair of dysfunctional equipment, submission of plan for decommissioning of obsolete equipment, submission of requirements for up gradation/ addition of equipment.
- 3.3 Creation and implementation of equipment maintenance (preventive & break down) plan.
- 3.4 Monitor performance of equipments through KPI.

- 4.1. DOHFW invites Expression of Interest from reputed entities/ firms for Biomedical Equipment Maintenance Service.
- 4.2. The project envisages that the entity will maintain & manage these equipments
- 4.3. It is envisaged that the entity will deploy trained staff and undertake maintenance and management of biomedical equipments.
