Minutes of Meeting

Subject: Minutes of the meeting held on 10.02.2022 (via Video Conference) under Chairmanship of Special Secretary (Environment) in reference to the decision of Airfield Environment Management Committee (AEMC) regarding illegal selling of meat in fruit and vegetable market at Dabri Mor.

A meeting was convened on 10.02.2022 at 04:00 PM (via Video Conference) under Chairmanship of Special Secretary (Environment) GNCTD in compliance to the decision of AEMC regarding Illegal selling of meat in fruit and vegetable market at Dabri Mor.

Meeting was attended by Dr. M.P.S Sodhi, Dy Director (Vetenary), South Delhi Municipal Corporation, Shri Yashpal, Superintendent Engineer, Delhi Development Authority, Shri PP Singh, Chief Airside Officer, Airside Management, Delhi International Airport (P) Limited and other officers from DIAL. Officers from DDA (Commercial Estate) did not attend the meeting.

At the outset, the Special Secretary (Environment) welcomed all participants. Scientific Officer (Env.) briefed the Chair about the decision of AEMC wherein DDA had been directed to inspect the area & revoke the permission given to the allotted stalls for non compliance of the waste management conditions and SDMC officer was directed to submit communication made to DDA regarding denial of the permission to the operating stalls.

With approval of the Chair, DIAL representative gave a presentation on status of illegal selling of meat in fruit and vegetable market at Dabri Mor and about the various communications of DDA & SDMC on the said issue.

DIAL representative also informed that a public grievance under rule 91 of Aircraft Rule 1937, had also been received from DGCA on 06.09.2021 regarding illegal selling of meat in fruit and vegetable market of Dabri Mor. Thereafter, a joint survey was carried out along with Dy. Director (VS) Najafgarh Zone, SDMC on 20.09.2021 and selling of fish/ chicken / mutton in open was observed.

SDMC, Veterinary Officer, Najafgarh Zone informed that all the allotted stalls do not fulfill the requirement of Meat shop License policy of the Municipal Corporation. As per DMC Act 1957, no meat shop is allowed to run without Municipal Trade License. The permission had been granted by Commercial Estate Branch of DDA for selling of fish/chicken/mutton vide letter dated 26.06.2018. SDMC (veterinary) Najafgarh Zone vide its letter dated 29.06.2021 had written to DDA that all allotted stalls do not fulfill the requirement of Meat Shop License policy of the Corporation. As per DMC Act 1957 no meat shop is allowed to run without Municipal Trade License & hence DDA should review the permission given to these stalls. The officer from SDMC also informed that the said stalls have earlier also been issued notices /challans and sealing process is also underway.

Due to no representation from DDA (Commercial Estate) in the meeting, action taken by DDA on the SDMC letter could not be ascertained.

However, keeping in view that DDA while issuing the allotment letter dt. 26.06.2018, has already requested SDMC to ensure compliance of Rule 91 of the Aircraft Rule 1937, the Special Secretary (Env.) directed SDMC, officer from Veterinary branch to ensure issuing of closure notice to all 28 shops operating at the site by 28th February 2022 as provision of Aircraft Rule and also send copy of the said notice to Delhi Police, DDA, DIAL and Department of Environment, GNCTD for further coordination. Also, Commercial Estate branch of DDA to respond to the SDMC letter dated 29.06.2021 regarding action taken.

The meeting ended with Vote of thanks to the Chair.
