Further candidature of above mentioned recommended candidates is purely provisional and subject to fulfilling all conditions of eligibility for relevant post, submission of documents and verification of information submitted by her in the Application Form and on the following terms and conditions:-

- The appointment of the abovementioned candidate is subject to:- Verification of Character and Antecedents, Medical Fitness Examination from the concerned Authority and Educational Qualification Certificates etc. Further, the Appointment will be subject to Verification of Reserved Category/ PH Certificate from the issuing authority (if applicable).
- 2. The appointment is subject to satisfactory completion of induction Training (if applicable).
- 3. The candidate will be on probation for a period of 02 years which can be extended at the discretion of the Competent Authority in future. On successful completion of probation period, his/ her service may be regularized.
- 4. On appointment, the candidate will be required to take an oath of allegiance to the Constitution of India and affirmation to that effect in the prescribed form.
- 5. The candidate so appointed to the post of Non-Teaching Specialist Grade-III will be bound to serve in any of the Hospital/Medical Institution under the Government of National Capital Territory of Delhi. The terms and conditions of the appointment will be subject to the instructions/ rules issued by the Government of National Capital Territory of Delhi from time to time.
- 6. The appointment shall be subject to submission of declaration regarding his/her marital status. In the event of him/her entering into or contracting a marriage with person having a spouse or he/she having a living spouse has entered into or contracted a marriage with any person, shall not be eligible for appointment.
- 7. The appointment can be terminated at any time by giving one month's notice during probation by either side. viz. the appointee or the appointing authority with or without assigning any reasons as per provision of extant/relevant rules.
- 8. In case any false information has been furnished or any factual information has been suppressed, which comes in notice at a later stage, he/she will be liable for removal from service, disciplinary proceedings or any other action as deemed fit.
- 9. The above mentioned candidates are directed to report to Medical Superintendent/Medical Director/In-charge of the allocated Institution/Hospital within 15 days from the date of issuance of this Order.
- 10. The concerned officers may be allowed to join their duties after completion of requisite formalities i.e. Medical Examination (if not already done) etc.
- 11. Other conditions of service shall be governed by the extant/ relevant rules, in force
