ORDER

Consequent upon recommendation by the Union Public Service Commission, the Lt. Governor of Delhi is pleased to offer the following recommended candidates Offer of Appointment to the post of Non-Teaching Specialist Grade-III, under Delhi Health Service (Allopathy Rules, 2009) on an initial pay matrix of 7th CPC level -11 of Rs. 67,700/- to 2,08,700/- Plus NPA & usual allowances as admissible under the extant rules:-

Further candidature of above mentioned recommended candidate is purely provisional and subject to fulfilling of all conditions of eligibility for relevant post, submission of documents and verification of information submitted by him/her in the Application Form to UPSC and on the following terms and conditions:-

The appointment of the abovementioned candidate is subject to:-

1. Verification of the Character Antecedents, Medical Examination from the concerned Authority and Educational Qualification Certificates etc. Further, the Appointment will be on the confirmation of Verification of Reserved Category/ PH certificate from the issuing authority (if applicable).
2. The appointment is subject to satisfactory completion of induction Training (if applicable).
3. The candidate will be on probation for a period of 02 years which can be extended at the discretion of the Competent Authority in future. On successful completion of probation period, his/ her service may be regularized
4. On appointment, the candidate will be required to take an oath of allegiance to the Constitution of India or an affirmation to that effect in the prescribed forms.
5. The candidate so appointed to the post of Non-Teaching Specialist Grade-III will be bound to serve in any of the Hospital/Medical Institution under the Government of National Capital Territory of Delhi. The terms and conditions of the appointment will be subject to the enforcement of instructions/ rules issued by the Government of National Capital Territory of Delhi from time to time.

6. The appointment shall be subject to submission of declaration regarding his/her marital status. In the event of him/her entered into or contracted a marriage with person having spouse or he/she is having a living spouse has entered into or contracted a marriage with any person, shall not be eligible for appointment.
7. If the candidate was previously working, then a Character Certificate issued by the Head of Department or any other Competent Authority of Hospital Medical Institution last attended is also to be submitted.
8. The appointment can be terminated at any time by giving one month's notice during probation by either side, viz. the appointee or the appointing authority with or without assigning any reasons as per provision of extent/relevant rules.
9. If any information submitted by the candidate proves to be false or if the candidate is found to have wilfully suppressed any material information, he/ she will be liable for removal from service, disciplinary proceedings or any other action as deemed fit.
10. If the above mentioned terms and conditions are acceptable to above candidates, the candidate is required to submit his/her acceptance in the office of the Deputy Secretary (HR-Med.), Department of Health & Family Welfare, GNCTD, 9th floor A-Wing Delhi Secretariat, Delhi, **within 15 days from the date of issuance of this letter.**
11. If acceptance of this letter is not submitted/ recommended candidates fail to report, within the prescribed time limit of **15 days** from the date of issuance of this letter, the offer of appointment will lapse automatically without any further notice.
12. However, within the period stipulated above any request for extension is submitted the same may be granted subject to approval by the Competent Authority, only in accordance with the terms & conditions laid down in the OM Dt. 06.06.1978 (MHA, Gol); OM Dt. 09.08.1995 (DoPT, MoPPGP, Gol) & OM Dt. 09.08.2017 (DoPT, MoPPGP, Gol).
13. The concerned officer may be allowed to join his/her duties after completion of requisite formalities i.e. Medical Examination etc.
14. Other conditions of service shall be governed by the extant/ relevant rules, in force.
