The offer of appointment is subject to the following terms and conditions:-

1. The appointment is purely temporary as per residency scheme.
2. The appointment is initially for a period of one year, may be extendable yearly for another term but not more than 03 years, including any service rendered as SR earlier on adhoc/regular basis in any recognized institution anywhere in India, subject to satisfactory work/conduct and performance provided by their respective In-Charges.
3. His/her appointment subject to his/her being declared medically fit by the medical board.

4. That appointment may be terminated at any time giving one month prior notice without assigning any reason thereafter.
5. The Private Practice of any kind what so ever is strictly prohibited. Besides the candidates will not work simultaneously as SR in any other hospital. Breach of this condition will result in termination of appointment.
6. Other condition of service will be governed by relevant rules and orders from time to time. If any declaration / information furnished by his /her prove to be false or willfully suppressed, he/she will liable to be removed from the service and/or any other action Govt. may deem necessary will be taken.
7. His/her appointment subject to his taking of an oath of allegiance/faithfulness to the constitution of India or making solemn affirmation to the effect that he/she is having one wife/ husband and he/she is not married to a person / woman who is already having one living wife/husband.
8. In case of resignation before completion of duration of service offered, they are required to give an advance notice of **thirty days**, failing which **thirty days** salary would be recovered. **No any kind of leave will be given during the notice period of resignation.**
9. The period of service rendered by you as Senior Resident in Govt. Hospital/ Autonomous Bodies founded by the Govt. prior to this appointment, if any, will count while reckoning the tenure as Senior Resident. In case he/she has done residency (adhoc/regular) in any Govt./Public Sector Hospital, the period thereof should be mentioned at the time of joining, as the same will be adjusted against the fixed tenure of Senior Residency.
10. The resident doctor must follow BMWM Practices as per guidelines of DPCC and a certificate of training of BMWM from the Nodal Officer (BMWM) shall be furnished for release of his/her salary.
11. In case he/she works for less than 89 days, no experience certificate will be issued.
12. Delay in completing the formalities may delay the release of salary and this will be his / her individual responsibility.
13. **He/She is required to submit Delhi Medical Council Registration certificate before joining. If not submitted already at the time of Interview.**
14. Leave shall be granted as per rules.
15. In case of unauthorized/willful absence of duties for more than 03 days, the appointment shall be terminated without assigning any reason.
16. No salary will be paid for any kind of unauthorized absence from duty even by the name of Strike.
17. No T.A & D.A. will be admissible to join the duty.

18. In case the offer is acceptable, he/she should report for joining within (07) Seven Days of issue of this offer of appointment, failing which it will be presumed that he/she is not interested to join. The offer will be cancelled without any intimation after the due date.
19. Litigations if any will be in the jurisdiction of Delhi.
20. He/She should attend CME held in this hospital on any working day/off day, otherwise the tenure will not be extended.
21. He/She should submit the details of Bank Account along with self attested copy of PAN while joining.
