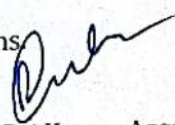
Appointment is subject to the Verification of DMC, Original Certificate and Medical Fitness report.

1. The appointment is initially made for a period of one year, may be extended up to maximum period of 03 years only including any service rendered as Senior Resident earlier on Ad-hoc/Regular basis in any recognized institutions subject to satisfactory performance, work and conduct report from concerned HOD.
2. His/Her appointment is subject to his taking oath of allegiance/faithfulness to the constitution of India or making solemn affirmation to the effect that he is having one wife and is not married to a lady who is already having one leaving husband.
3. In case of unauthorized of duty for more than 3 days (Three Days Back To Back) his/her services may be terminated without any prior notice.
4. No TA/DA will be admissible to join the duty.
5. The candidate should deposit a security deposit of Rs. 5000/- for availing hostel facility. Hostel Facility is availability. The security money will be refunded on completion of their tenure/acceptance of resignation and on production of NO DUES CERTIFICATE, failing which, it will be forfeited.
6. He/She should submit the bank detail of bank account while joining for salary purpose.
7. He/She should submit proof of permanent address.
8. The appointment may be terminated at any time by One Month notice given by either side i.e., the appointee or the appointing authority. No notice will be required if terminated on disciplinary ground.
9. In case appointee avails any kind of leave during notice period, the date of resignation would be postponed further according to the period of leave.
10. **In case appointee does not serve the notice for resignation, One Month salary would be deducted.**
11. Private practice of any kind is not allowed.
12. Courts of Delhi/New Delhi shall have the jurisdiction in connection with any dispute litigation.
13. Earned leave will be granted @ Two and half days per month of completed service.
14. Leave encasement on termination of service during the currency/expiry of contract is not allowed.
15. Leave admissibal as per residency scheme and as per leave rule.
16. In case appointee avails any kind of leave during notice period, the date of resignation would be postponed further according to the period of leave.
17. Discipline. He/She will have to wear white coat with the name badge while on duty. He/She will have to attend his duty punctually and regularly.

18. All the selected candidate shall have attend a compulsory training on **BIO Medical Waste Management**. For venue and schedule of the programme, must contact MO-I/C, BMWM, DCB Hospital.
19. The employee will not entitled to any other financial benefit viz allowances, perks, etc. Other than the monthly remuneration (tax will be deducted at source, if necessary).

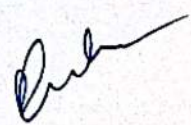
