**MEMORANDUM**

- (1) The appointment will initially be for a period of 44 days or **till regular appointment is made**, whichever is earlier. The appointment is extendable for a period of maximum one year including period of JR ships done elsewhere earlier, subject to satisfactory work & conduct, with intermittent breaks after every 44 days.
- (2) He/She should report for duty within 07 days from the date of issue of this offer, failing which this offer shall stands cancelled and submit an undertaking as per annexure enclosed.
- (3) He/She will produce all the original certificates for verification and also DMC Registration certificate.
- (4) The appointment is further subject to the conditions that:
  - (a) He/She should state that whether he is serving or under any obligation to serve in any central/state Govt. department or public authority.
  - (b) Other conditions will be governed by the Residency Scheme.
  - (c) He/She can resign by giving 7 days' notice. If he/she wishes to resign without 07 days' notice, he will remit seven days' salary.
  - (d) If any information furnished found false or willfully suppressed any information, his/her residency will be terminated.
  - (5) The appointing authority reserves the right to terminate the residency without mentioning any reason thereof.
  - (6) First salary will be released after fulfilling the following mandatory requirements:-
    - (a) He/She should contact the In-charge, Blood Bank, for attending sensitization training in Blood Transfusion which will be conducted on very Friday from 2:00 to 3:00 P.M.
    - (b) Will contact the In-charge, BMW.
    - (c) Get registered for bio-metric attendance.
    - (d) If earlier worked in any Central/Delhi Government-run hospital, he/she should get the LPC issued from that institution, failing which his/her salary will not be drawn.
    - (e) **Experience certificate will be issued to those who will complete minimum six months of Junior Residency .**
    - (f) **Selected candidate is directed to visit room no. 48 for medical fitness and registered yourself on HPR.**
