- (i) The appointment will be, initially, for a period of 44 days or till regular appointments is made whichever is earlier.
- (ii) The maximum period of engagement will be 3 years, with intermittent breaks after every 44 days including previous residency in other Govt. Hospitals.
- (iii) She/he should report for duty within 07 days from the date of issue of this offer, failing which this offer shall stands cancelled.
- (iv) She/he will produce all the original certificates for verification and also DMC Registration certificate.
- (v) The appointment is further subject to the conditions that;
 - (a) She/he should state that whether he is serving or under any obligation to serve in any central/state Govt. department or public authority.
 - (b) Other conditions will be governed by the Residency Scheme.
 - (c) She/he can resign by giving seven days' notice. If he/she wish to resign without 07 days' notice, s/he will remit seven days' salary.
 - (d) If any information furnished found false or willfully suppressed any information, his/her residency will be terminated.
- (vi) The appointing authority reserves the right to terminate the residency without mentioning any reason thereof.
- (vii) First salary will be released after fulfilling the following mandatory requirements;
 - (a) She/he should contact the In-charge, Blood Bank, for attending sensitization training in Blood Transfusion which will be conducted on very Friday from 2:00 to 3:00 P.M.
 - (b) She/he will contact the In-charge, BMW.
 - (c) She/he will get registered for bio-metric attendance.
- (viii) Experience certificate will be issued to those who will complete minimum one year of Senior Residency.
- (ix) Selected candidates are directed to visit room no. 48 for medical fitness registered yourself on HPR.
