Consequent upon the selection through Walk-in-Interview held in MAMC, GNCTD from 24.02.2026 to 11.03.2026 as communicated vide Order No. No.F-22(177)/2026/MC/E-II/8352 dated 04/06/2026 issued by Health and Family Welfare Department, Maulana Azad Medical College, Govt of NCT of Delhi, wherein the Non-Teaching Specialist have been engaged on contract basis for 01 year.

Accordingly, offer of appointment to the post of Non-Teaching Specialists (above) on Contract Basis for one year is subject to the following terms and conditions:

1. Consolidated Remuneration shall be as per Level-11 of 7th CPC (basic pay + other applicable allowances).
2. Agreement in the Standard Prescribed Format shall be signed and executed between the contractual appointee and the MS/MD of concerned hospital.
3. The selected appointee on contractual basis shall submit two original sets of signed contractual agreement before joining.
4. Candidates should have valid DMC/Dental Council Registration Certificate.
5. Any letter of resignation submitted by the contractual employee will be treated as a letter communicating the intention of the contractual employee to terminate the contract. If a contractual employee wishes to terminate the contract by giving 30 (thirty) days notice, it would be accepted by the Medical Director of the institution, after getting a no dues certificate from the branches concerned. No notice is required, if service is terminated on disciplinary grounds/falsification of declared information/joining of regular incumbent.

6. The Tenure of contractual appointment will be for a period of one year or till a regular incumbent joins whichever is earlier. The contractual appointment will be terminated on joining of a regular incumbent at any time.
7. Appointee/employee to the post will not be entitled to claim permanent position/regularization of services in any condition.
8. The above posts shall be filled on regular basis through UPSC and the contractual doctors will have no claim on regular recruitment solely because of contractual engagement served at the concerned hospital.
9. Private Practice of any kind is not allowed.
10. Contractual employees are governed only by the terms and conditions mentioned in the contract agreement and are not entitled for any other allowances, financial benefits or concessions of medical facilities, grant of LTC benefits, GPF, Pension Benefits, DGEHS, Provisions of FR/SR etc., that are applicable to only regularly appointed doctors of Government of NCT of Delhi.
11. The appointed candidate will not be entitled to any kind of accommodation and other concessionary allowance.
12. The timings of work/duties/responsibilities of contractual engagement would generally be same as those of regular appointed specialists.
13. Engagement/Appointment shall be subject to Medical Fitness and Verification of Certificates/documents/Police Verification.
14. SC/ST certificates issued only from Competent Judicial/Revenue authorities shall be accepted.
15. OBC Category Candidates are required to submit their Caste Certificate along with Non-Creamy Layer (NCL) Certificate, issued after 31.03.2025 by Govt. of NCT of Delhi in r/o the "Community" they belong to, which is recognized as Other Backward Class under the Government of NCT of Delhi Notification no. F.28(93)/91-92/SCST/P&S/4388 dated 1995-01-20, published in the Gazette of Delhi Extraordinary Part-IV. EWS certificate valid for financial year 2025-2026 shall only be accepted.
16. In case of EWS the engagement is provisional and is subject to the Income and Asset Certificate being verified through the proper channels and if the verification reveals that the claim to belong to EWS is fake/false the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of Indian Penal Code for production of fake/false certificate.
17. The appointment will be terminated at any stage if any declaration/information furnished is found false or any material/fact is suppressed willfully or on any disciplinary grounds.
18. The candidate who is already in Government service should apply along with 'NOC' from the Employer.
19. Any canvassing by or on behalf of the candidate or any outside influence in any form with regard to selection will lead to disqualification.
20. In case of any legal dispute, the jurisdiction of court will be Delhi/New Delhi only.

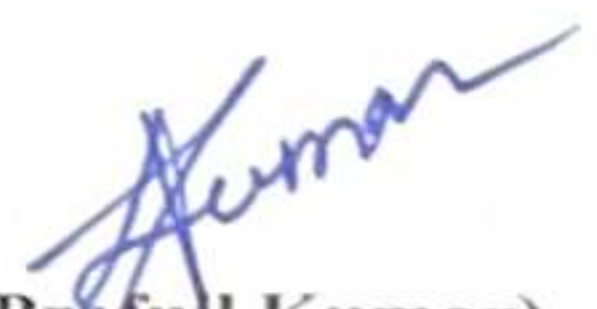
