RECRUITMENT NOTICE FOR CONSULTANTS

Applications are invited for engagement of retired physiotherapist and occupational Therapist to fill up to vacant posts of this hospital purely on Contract Basis. The details are mentioned below:-

1. Name of Post :- Physiotherapist and Occupational Therapist.
2. Number of Posts :- 2 (1 Physiotherapist + 01 Occupational Therapist)
3. Monthly remuneration :- (Last Pay drawn minus-Basic Pension) + DA per month
4. Essential Educational Qualification :- As per RRs of the post.
5. Age limit :- Maximum 65 years.
6. Mode of Selection :- By interview
7. Submission of Application :- Till 24.04.2026 up to 4:00 PM.
8. Date/venue of Interview :- Shall be intimated after scrutiny of applications.
9. Duly completed applications in all respect (alongwith all supporting documents) must reach office of **Medical Superintendent, Aruna Asaf Ali Govt. Hospital, 5, Rajpura Road, Civil Lines, New Delhi-110054 latest by 24.04.2026 by 4:00 PM.** Incomplete applications or application received after schedule date & time shall be summarily rejected without any notice.
10. The engagement of retired employee shall be governed as per terms and conditions mentioned in H&FW Department circular dated 25.08.2017, 13.10.2017, and Finance Department, GNCTD OM No. F. 20/4/2015-AC/204-248 dated 04.12.2015.

The Terms & Conditions are as under:-

- A. The Engagement of retired Government servant as Consultant should be against a vacant sanctioned post. The Engagement of consultant would be on full-time basis and they would not be permitted to take up any other assignment during the period of consultancy.
- B. The engagement of consultant should initially be for a period of one year. However, it can be extended further subject to the satisfactory performance of the consultant and depending upon the specific job and the time frame for its completion. The total period of engagement as consultant should not exceed 5 years. In no case the consultant should be allowed beyond five years or 65 Years of age whichever is earlier. The maximum age limit of engagement as consultant shall be 65 years.

- C. The amount of monthly consolidated remuneration/ fee in the case retired Government officials appointed as Consultants shall be last Pay minus basic Pension plus DA at the applicable rate. His/her engagement as consultant shall not be considered as a case of re-employment.
- D. The consultants shall be not be entitled to any allowance such as House Rent Allowance, reimbursement of call charges of Residential Telephone/ Mobile, Transport Facility, Residential Accommodation, Personal Staff, etc.
- E. No Government vehicle shall be provided to the consultants.
- F. No TA/DA shall be admissible for joining the assignment or on its completion. Consultants will not be allowed foreign travel at Government expenses. However, consultants shall be allowed TA/DA for their travel inside the country in connection with the official work, if any, as per their entitlement as on the date of retirement.
- G. Consultants shall be eligible for 8 days leave in a calendar year on pro-rata basis. Therefore, a consultant shall not draw any remuneration in case of his/her absence beyond 8 days in a year (calculated on pro-rata basis). Also unavailed leave in a calendar year cannot be carried forward to next calendar year.
- H. The engagement of consultants is of a temporary nature and the engagement can be cancelled at any time by the department without assigning any reason.
- I. The retired employee to be engaged as consultant should be clear from vigilance angle at the time of retirement.
- J. The appointee shall bear full responsibility of the work as prescribed in the duties. In addition, he/she will also be required to discharge the duties as and when required by any authority so authorized.
- K. Please bring the following original documents alongwith self attested copies with application form:-
- Age proof document (10th certificate).
 - Diploma, Degree & Marksheet of the candidate.
