Terms & Conditions of retired Doctors as Medical Officers on contract basis against vacant sanctioned posts:-

- 1. The engagement of retired Government doctors as Medical Officers (M.Os) is against a vacant sanctioned post. The engagement of M.O is on full-time basis and they will not be permitted to take up any other assignment during the priod of appointment.
- 2. The appointment is purely on contract basis and will not bestow upon him/her any claim for regular appointment.
- 3. The contract appointment will be for one year in the first instance or till the post is filled upon regular basis through UPSC, whichever is earlier. The maximum age limit for engagement shall be till attaining the age of 65 years.
- 4. The amount of monthly consolidated remuneration/ fee in the case of retired Government doctors appointed as M.O shall be Last Pay minus Basic Pension plus DA at the applicable rate. However, a retired Government doctor appointed as M.O shall continue to draw pension and the dearness relief thereon during the period of his engagement. His/Her engagement shall not be considered as a case of re-employment.
- 5. The M.Os shall not be entitiled to any allowance such as House Rent Allowance, reimbursement of call charges of Residential Telephone/mobile, Transport facility, Residential Accommodation, Personal Staff, etc.
- 6. No Government vehicle shall be provided to them.
- 7. The appointee shall not be entitled to LTC.
- 8. No TA/DA shall be admissible for joining the assignment or on its completion. The officers will not be allowed foreign travel at Government expenses.
- 9. M.Os shall be eligible for 8 days leave in a calendar year on pro-rata basis. Therefore, they shall not draw any remuneration in case of their absence beyond 8 days in a year (calculated on pro-rata basis). Also unavailed leave in a calendar year cannot be carried forwad to next calendar year.
- 10. The engagement of M.Os is of a temporary nature and the engagement can be cancelled at any time by the department without assigning any reason.
- 11. Before engaging any retired Government doctors as M.O, it would be ensured that the retired officer is clear from vigilance angle.
- 12. If any declaration/certificate etc. given or information furnished by him/her proves to be false or if he/she is found to have willfully suppressed any material/information, he/she will be liable to be removed from service forthwith.
- 13. Private practice of any kind, whatsoever, inculding laboratory and consultancy practice is prohibited.
- 14. The other terms and condition of contractual appointment will be governed by relevant rules, orders, conditions and various court decisions that may be force from time to time.
