Notice for walk in interview to the post of Sr. Resident on ad-hoc basis

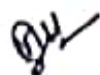

[I]. ELIGIBILITY CRITERIA FOR THE POST OF SENIOR RESIDENT :-

- 1. Qualifications:** The qualification for the post of SRs is Post Graduate Degree (MD/MS/DNS) Diploma in concerned specialty. If PG Degree/Diploma candidates are not available, the candidate who have minimum 02 year experience after graduation (MBBS) from Govt./Govt. Empanelled Hospital may be considered wherein 01 year experience in the concerned specialty. Must not have completed 03+01 years Senior Residency in any recognized institute including regular or Ad-hoc basis.
- 2. Age Limit -** Age limit shall be maximum of 45 years as on date of interview as per order No. DHF&W/Q015/57/2016-HR-Medical-Secy(H&FW)#11245062/1502-08 dt. 26/11/2016 issued by H&FW department, GNCTD. The age relaxation for reserve category candidate as per rules.
- 3. Pay Scale:-** Pay Matrix of Level -11 (Rs. 67,700 – 208700) plus other admissible allowances per month under residency scheme.

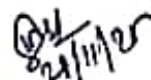


4. The candidate must have valid registration with Delhi Medical Council.
5. Appointment will be considered for a period of 89 days initially or till recruitment of Senior Resident Doctors by centralized committee, whichever is earlier.
6. Appointment will be subject to Medical fitness and verification of certificates of educational qualification/age/cast/DMC registration and internship completion certificate etc.

(II) GENERAL CONDITIONS FOR RECRUITMENT:

- [1] All the eligible candidates should report at the Administrative Block at 10.00 AM. {Time for enrollment shall be from 10.00 A.M. to 12.00 noon only} on the day of interview.
- [2] For candidates applying for OBC category, the certificate must be issued by the Competent Authority of Govt. of NCT of Delhi.
- [3] The reservation for handicapped/ex-serviceman will be as per the Government rules.
- [4] The number of vacancies may vary.
- [5] No TA/DA will be given for appearing in the interview.
- [6] Candidates are advised to ensure that they fulfill the eligibility criteria as mentioned in the advertisement before appearing the interview.
- [7] Other service conditions will be applicable as per service conditions prescribed from time-to-time by the Govt. of NCT of Delhi.
- [8] Jurisdiction of Dispute- In case of any legal dispute the jurisdiction of court will be Delhi/New Delhi.
- [9] There is no fee for appearing in the interview.
- [10] Selected candidates shall be allowed to join within 05 days of issue of the offer letter failing which the offer shall stand automatically cancelled.

Eligible candidates may appear in the interview with their application form at the Administrative Block on the date of interview at 10:00 a.m. with self-attested copies of testimonials. Original certificates/documents are also required at the time of interview for verification.
