INTERVIEW FOR THE POST OF SR. RESIDENTS AND JR. RESIDENTS (MBBS AND DENTAL) ON ADHOC BASIS IN DELHI PRISONS ON 02.01.2026 (JR. RESIDENTS-MBBS), 05.01.2026 (JR. RESIDENTS -DENTAL) AND 06.01.2026 (SR. RESIDENTS) RESPECTIVELY.

Applications are invited from the interested and eligible candidates for the post of, Jr. Resident (MBBS), Jr. Residents (Dental) and Sr. Residents Doctors on adhoc basis in Delhi Prisons (Central Jail Hospital, Tihar, Rohini and Mandoli). Candidates are required to submit the duly filled applications form with all requisite educational and other documents **latest by 30.12.2025 through Speed post OR by hand (between 10:00 AM to 05:00 PM, Monday to Friday) to R&I Section, Prison Head Quarter, Near Lajwanti Garden Chowk, Janak Puri, New Delhi-110058.**

The details regarding educational qualification, emoluments, age limit, terms and conditions etc, in r/o **Sr. and Jr. Residents [MBBS & DENTAL]** are as under:-

Minimum Academic/professional Qualification, age limit, emoluments, tenure etc, for the posts of Sr. Residents and Jr. Residents (MBBS & Dental) are as under:-

QUALIFICATIONS:-

Sr. Residents:-

1. The minimum qualification for selection as Sr. Resident in any specialty will be a post-graduate degree or a Diploma in a concerned specialty from recognized university/institution.
2. If candidates having post graduate Degree or a diploma are not available in any particular specialty then candidates who have 02 years post MBBS Experience with at least 01 year in concerned Speciality from Govt./Govt. Panel Hospitals will be considered for the selection.

Jr. Residents (MBBS):-

1. MBBS from recognized university/institution.
2. **Internship:-Internship should be completed on OR after 30.12.2023.** Those candidates/applicants, who have completed their internship before 30.12.2023 can appear in the interview, however he/she will be considered and offer residency only if no fresh Junior Residents (MBBS) are available.

Jr. Residents (Dental):-

1. BDS Degree from recognized university/institution.
2. **Internship:-Internship should be completed on OR after 30.12.2023.** Those candidates/applicants, who have completed their internship before 30.12.2023 **need not apply.**

AGE LIMIT:-

1. **For Sr. Residents:-** 45 years for General & EWS, 48 years for OBC and 50 years for SC/ST candidates as on 30.12.2025.
- 2 **For Jr. Residents (MBBS and Dental):-** 30 years for General & EWS category 33 years for OBC and 35 years for SC/ST candidates as on 30.12.2025.

OB C candidate should have OBC certificate issued by Delhi Government only with Non Creamy Layer issued during the current financial year 2025-2026. Candidates having OBC certificate from other state will be considered under UR Category.

Further, in case of non-availability of candidates, for the post of Sr. Residents and Jr. Residents (MBBS) as per the relevant scheme mentioned above, candidates may be considered in terms of the relaxation of provision as per circular No. F.121/26/2010/H&FW/1996/2045 Dated 10.06.2011, issued by H&FW Department, GNCT of Delhi, with the following relaxation.

Sr. Residents:-

Senior Residents who have completed Three year of Senior Residency may be allowed to re-appear for interview for selection and will be offered residency only if no fresh Senior Residents are available. There would be no extension for any senior resident beyond one year appointed under this relaxed Provision.

Jr. Resident (MBBS):-

01. Upper age limit for eligibility will be 40 years in place of existing 30 years of age.
02. Post graduate Doctors who are interested to serve as Junior Residents will be allowed to join as Junior Residents if fresh graduate are **not available**.
03. Junior Residents who have completed one year of Junior Residency may be allowed to again appear for interview for selection and will be offered residency only if no fresh junior residents are available. There would be no extension for any junior resident beyond one year of appointment under relaxed provisions.

However, Candidates applying under relax norms will be considered for interview only if applications under fresh category received are less than double of vacant posts in each category.

EMOLUMENTS:-

SR. Residents: - As per 7th CPC pay matrix level 11, Pay Rs. 67700/- plus usual allowances as admissible under the rules

For Jr. Residents (MBBS & Dental):- As per 7th CPC pay matrix level 10, Pay Rs. 56100/- plus usual allowances as admissible under the rules.

TENURE OF RESIDENCY:-

ON ADHOC BASIS: - The appointment will be initially appointed for a period of 89 days (44 days in case of selection of UR category candidate against reserved posts of EWS/OBC, SC & ST due to non availability of reserve category candidates) OR till appointment is made by the Centralized Recruitment Committee/H&FW Department/Delhi Prisons Authority, whichever is earlier. In case of no regular appointment of Sr. Residents and Jr. Residents (MBBS & Dental) is made by the Centralized Recruitment Committee/H&FW Department/Delhi Prison Authority, as the case may be, the tenure of Sr. Residents and Jr. Residents (MBBS & Dental) can be further extended for a further period of 89 days (44 days in case of selection of UR category candidate against reserved posts of EWS/OBC, SC) subject to satisfactory work and conduct/performance **(with one day compulsory break)** time to time for a **maximum period of 03 years in respect of Sr. Residents and 01 year in respect of Jr. Residents (MBBS & Dental) respectively**, including the period served in any Govt. Hospital/Health Institution, if any OR till appointment of Sr./Jr. Residents is made by the Centralized Recruitment Committee, constituted by the Hon'ble LG of Delhi/H&FW Department/Delhi Prison Authority, whichever is earlier.

However, services of Sr. Residents, JR (Dental) and Jr. Resident (MBBS) who will be selected against the sanctioned vacant posts of Specialists, Dentist and GDMOs respectively will be terminated immediately as per LIFO (Last In First Out) method applicable as per merit in case of joining of Specialist/Dentist/GDMOs respectively through H&FW Department, GNCT of Delhi.

Other Conditions/requirements:-

1. The number of vacancies as shown above is subject to change at any stage.
2. Out of total posts of, 4 % posts are reserved for persons with disabilities as per rule.
3. Registration with Delhi Medical Council/Delhi Dental Council, as the case may be, is mandatory as on date of interview.
4. The posts will be filled up in phases as per availability of vacancies and as per need of the department. The number of vacancies as shown above may subject to change at any stage.
5. Appointment shall be subject to medical fitness and verification of educational Certificates, caste certificates from the concerned authorities.
6. Selected candidates have to submit Police clearance certificate within one month from the date of joining. Salary will be released only after submission of Police Clearance Certificate.
7. Selected candidates have to submit a declaration whether his/her relative/known to person is lodged inside the Tihar, Rohini and Mandoli.

8. OBC reservation benefit shall be given to only those candidates who are in possession of OBC Certificate issued by the Competent Authority of the Govt. of NCT of Delhi for the caste recognized as OBC by the Government of NCT of Delhi. Candidates belonging to OBC category would be required to submit the non- creamy layer (NCL) certificate issued from the Competent Authority of the Govt. of NCT of Delhi during the current financial year 2025-2026. OBC (Outside Delhi) candidates will be treated as Un-reserved candidate and they must apply under UR category.
9. Candidates applied under EWS category, must have valid EWS certificate during the current financial year 2025-2026.
10. No TA/DA will be paid for appearing in the interview.
11. The service of Resident Doctors will be governed by the residency scheme of Govt. of India/Civil Services (Temporary Rules).
12. In case of non availability of SC, EWS and OBC candidates the posts shall be filled on adhoc basis for 44 days from candidates of other/General category.
13. If the selected candidates wants to resign, he/she should give a prior notice of 07 days.
14. The selected candidate can be posted in any Jail of Delhi Prisons as per requirement i.e in Tihar, Rohini and Mandoli.
14. Panel of wait listed candidates, 2 times of selected candidates/posts will be prepared and if any vacancies arising in future, the same will be filled from the panel. The Panel shall be valid for 06 months from date of publication of result of the interview OR till fresh selection process is carried out, whichever is earlier.
15. If any information submitted/provided by the candidate found incorrect at any level, his/her candidature is liable to be cancelled and necessary action as deemed fit will be taken.
16. The Contract of appointment can be terminated at any time without assigning any reason.
