SENIOR RESIDENT

Qualification:

a) M.B.B.S with PG Degree or Diploma in concerned Specialty from recognized university. The candidate must have completed internship.

b) If no candidte with MBBS and PG Degree/Diploma in Biochemistry department appeared in the interview, then the candidates with M. Sc. With Ph. D degree in medical Biochemistry as per NMC rules may be allowed to appear in the interview.

c) If no candidate with MBBS and PG Degree/Diploma is available for the interview then the candidates with three years' experience from a reputed Medical Institution in the concerned specialty may be allowed to appear in the interview.

Emoluments Level 11, Cell 1 (Basic Rs. 67700 /-) and usual allowances as admissible under the rules. Note:-

- 1. All the posts are provisional and the numbers of vacancies are subject to change without any notice.
- 2. The candidate having registration with the respective State can appear for interview but in case of selection they have to submit the DMC registration within one month of joining.
