The interview will be continued on Every day except holidays, till vacant post gets filled in the department of Obs/Gynae and Anaesthesia.

In exigency the candidates as per eligibility criteria are not available the eligibility criteria of with 2years'+ experience from Department of Obs/Gynae shall be considered.

Only candidates who fulfill the eligibility criteria as per Residency scheme may appear before the interview panel as per the schedule with their original documents along with the photo copy of the following documents as under :-

**Submission of application will be 09:30:AM to 11:30AM Room No.3002, 3<sup>rd</sup> Floor, Administration Branch, DCB hospital.**

- Qualification:-** Post Graduate Degree (MD/MS/DNB, Diploma) in the concerned disciplines from a recognized university/ institution. Must not have completed 03 years Senior Residency in any recognized institutions including regular and ad-hoc basis.
- Emoluments:** As per 7<sup>th</sup> CPC, Pay Matrix Level -11 (Rs.67,700-208700) and other allowances as admissible under the rule.

- Age limit:** 45 years for GEN, 5 years relaxable for SC/ST and 3 years for OBC candidates (belonging to Delhi only) are required to submit their caste certificate (issue before the



date of application) alongwith the current Non Creamy Layer certificate issued by the Govt. of NCT of Delhi only.

iv. **Application not accepted without DMC certificate.**

v. Those candidates who applied with 03 years' experience post MBBS should have valid DMC certificate of MBBS (Delhi).

**Tenure:-** The appointment will be initially period for 89 days . That can be extended further up to a maximum period of 03 years subject to satisfactory performance, work and conduct report from concerned HOD.

Further, in case of non availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of the relaxation of provision as per circular No. F.121/26/2010/H&FW/1996-2045 dated 10.06.2011 of Deptt., of H&FW, GNCT of Delhi with the following relaxation:

1. Upper age limit for eligibility for SR will be 45 years.
2. In case non availability of regular Candidates under SC/ST/OBC/EWS Category, vacancies may be filled up from General Categories candidates for 89 days on Ad-hoc basis (or till regular candidate joins in respective category whichever is earlier).
3. In case of non availability of fresh candidates, candidates who have completed three years of Residency as Senior Residents also be allowed to appear in the interview.
4. **The number of vacancies may change depending on the number of seats available on the day of the interview.**
5. In case of non-availability of candidate with PG Degree/Diploma, candidate with three years' experience in the respective specialty will be considered.
6. Separate merit list for candidates i.e., those who have completed 03 years of Sr. Residency and who are overage would be prepared.
7. Firstly, the list containing the names of fresh candidates would be exhausted for appointment and the second list would be used only after that.
8. All Appointment for Resident ship from second list will be for 89 days only (extendable upto three years) subject to satisfactory performance, work and conduct report from concerned HOD.
9. Appointment shall be subject to medical fitness & verification of original certificates.
10. Reservations of Person with Disability will be as per Government Rules.

**Other conditions/requirements:-**

- I. The service of Senior Residents shall be governed by residency schemes of Govt. of India/Civil Services (Temporary Rules).
- II. Candidates are required to bring all original certificates and testimonials along with two passport size photograph on the date of interview.
- III. The posts will be filled up in phases as per availability of vacancies.
- IV. Appointment shall be subject to verification of certificates.
- V. No TA/DA will be paid for appearing in the interview.
- VI. The appointment may be terminated at any time by 7 days notice given by either side i.e., the appointee or the appointment authority. No notice is required if service are terminated on disciplinary grounds.
