1. Number of Positions:

2. Nature of Engagement:

Contractual engagement for an initial period of six months, extendable further as per requirement or until the posts are filled on a regular basis.

3. Eligibility Criteria:

- Should have retired from the post of Senior Assistant/Asstt. Section Officer and above.
- 5. Must have sound knowledge of office procedures, noting/drafting, and computer applications.

Should not be more than the upper age limit prescribed for contractual engagement of retired personnel as per Government guidelines. Maximum age limit period not be beyond 65 years.

Terms & Condition for offer of appointment Engagement of Retired Government Officers as

The offer of appointment shall be subject to the following conditions.

- 1. The engagement of consultants is of a temporary nature and the engagement can be cancelled at any
- 2. The engagement of retired Government servant as Consultant should be against a sanctioned vacant post. The engagement of consultant would be on full-time basis and they would not be permitted to take up any other assignment during the period of consultancy.
- The engagement of consultant shall initially be for a period of six (06) Months or till regular
- 4. However, the tenure shall be extended further subject to the satisfactory work and conduct, need assessment and approval of competent authority. The total period of engagement as consultant shall not exceed 5 years. In no case the consultant should be allowed beyond five years. The maximum age limit of 'engagement as consultant shall be 65 years.
- 5. The amount of monthly consolidated remuneration / fee in the case of retired Government officials appointed as Consultants shall be Last Pay minus Basic Pension plus DA at the applicable rate. However, a retired Government official appointed as Consultant shall continue to draw pension and the dearness relief thereon during the period of his engagement as Consultant. His/her engagement as consultant shall not be considered as a case of re-employment.
- 6. In case of Central Government retirees under the NPS, an amount equivalent to 30% of the last basic pay as drawn at the time of retirement shall be deducted from the last basic pay and the resultant amount shall be the fixed monthly amount as remuneration in accordance to Office Memorandum
- 7. The Consultants shall not be entitled to any allowance such as House Rent Allowance, reimbursement of call charges of Residential Telephone/mobile, Transport facility, Residential accommodation,
- No TA/DA shall be admissible for joining the assignment or on its completion. Consultants will not be allowed foreign travel at Government expenses. However, Consultants shall be allowed TA/DA for their travel inside the country in connection with the official work, if any, as per their entitlement as on the date of retirement. No. govt. vehicle shall be provided to the consultants.
- 9. Consultants shall be eligible for 8 days' leave in a calendar year on pro-rata basis. Therefore, a consultant shall not draw any remuneration in case of his/her absence beyond 8-days in a year (calculated on pro-rata basis). Also unavailed leave in a-calendar year cannot be carried forward to next calendar year.
- 10. The engagement of Consultants shall be of temporary nature and the engagement can be cancelled at any time by the department without assigning any reason,
- 11. Before assigning any retired govt. official as Consultant the department shall ensure that the candidate is clear from vigilance angle.

12. The selected/shortlisted candidate shall submit Medical fitness certificate by the medical board of this hospital before joining.
