- II. Emoluments: As per 7<sup>th</sup> CPC, Pay Matrix Level -11 (Rs.67,700-208700) and other allowances as admissible under the rule.
- III. Age limit: 45 years for GEN, 5 years relaxable for SC/ST and 3 years for OBC candidates (belonging to Delhi only) are required to submit their caste certificate (issue before the date of application) alongwith the current Non Creamy Layer certificate issued by the Govt. of NCT of Delhi only.

V. Those candidates who applied with 03 years' experience post MBBS should have valid DMC certificate of MBBS (Delhi).

7. Appointment shall be subject to medical fitness & verification of certificates.
