The PwD candidates shall be considered as per rules.

In exigency the candidates as per eligibility criteria are not available the eligibility criteria of with 2years' experience from Department of Anaesthesia and Obs/Gynae shall be considered.

Only candidates who fulfil the eligibility criteria as per Residency scheme may appear before the interview panel as per the schedule with their original documents along with the photo copy of the following documents as under :-

- I. Qualification:- Post Graduate Degree (MD/MS/DNB, Diploma) in the concerned disciplines from a recognized university/ institution. Must not have completed 03 years Senior Residency in any recognized institutions including regular and ad-hoc basis.
- II. Emoluments: As per 7th CPC, Pay Matrix Level -11 (Rs.67,700-208700) and other allowances as admissible under the rule.
- III. Age limit: 45 years for GEN, 5 years relaxable for SC/ST and 3 years for OBC candidates (belonging to Delhi only) are required to submit their caste certificate (issue before the date of application) alongwith the current Non Creamy Layer certificate issued by the Govt. of NCT of Delhi only.

IV Application not accepted without DMC certificate.

V. Those candidates who applied with 03 years' experience post MBBS should have valid DMC certificate of MBBS (Delhi).

Tenure:- In pursuance to order no. 11/79/H&FW/HR-MED/2023#112745287/1877-79 dated 03/10/2024. The appointment will be initially for 89 days on Adhoc Basis. That can be extended further up to a maximum period of 03 years subject to satisfactory performance, work and conduct report from concerned HOD or till central recruitment whichever is earlier.

Further, in case of non availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of the relaxation of provision as per circular No. F.121/26/2010/H&FW/1996-2045 dated 10.06.2011 of Deptt., of H&FW,GNCT of Delhi with the following relaxation:

- 1.Upper age limit for eligibility for SR will be 45 years.
- 2.In case non availability of Candidates under SC/ST/OBC/EWS Category, vacancies may be filled up from General Categories candidates for 89 days on Ad-hoc basis (or till regular candidate joins in respective category whichever is earlier).
- 3.In case of non availability of fresh candidates, candidates who have completed 03 years of Residency as Senior Residents also be allowed to appear in the interview.
- 4.In case of non-availability of candidate with PG Degree/Diploma, candidate with two years' experience in the respective specialty will be considered.
- 5.Separate merit list for candidates for candidates under relaxed category will be made.
- 6.Firstly, the list containing the names of fresh candidates would be exhausted for appointment and the second list would be used only after that.
- 7.Appointment shall be subject to medical fitness & verification of certificates.
- 8.Reservations of Person with Disability will be as per Government Rules.

Other conditions/requirements:-

- I. The service of Senior Residents shall be governed by residency schemes of Govt. of India/Civil Services (Temporary Rules).
- II.Candidates are required to bring all original certificates and testimonials along with two passport size photograph on the date of interview.
- III.The posts will be filled up in phases as per availability of vacancies.
- IV.Appointment shall be subject to verification of certificates.
- V.No TA/DA will be paid for appearing in the interview.
- VI.The appointment may be terminated at any time by 7 days notice given by either side i.e., the appointee or the appointment authority. No notice is required if service are terminated on disciplinary grounds.
