INTERVIEW NOTICE

Applications are invited in the prescribed format from eligible candidates to fill up the vacant post of Junior Residents on ad-hoc basis for a period of 44 days in Dr. Hedgewar Arogya Sansthan, in accordance with order no. F.11/79/Hr-med/2023#112745287/1877-79 dated 03.10.2024 of Health & Family Welfare, Govt. of NCT of Delhi and in accordance with DOPT, Govt. of India OM no. 41034/4/2022-Estt.(Res-I) dated 21.11.2022, under the residency scheme as per below schedule. The candidates are directed to report in the Establishment Branch, DHAS Hospital on the date of interview as given below. Registration of the candidates appearing for interviews will be done from 9:30 am to 11:30 am on the date of interview.

Qualification: - MBBS from recognized university/institution and must possess valid Registration Certificate from Delhi Medical Council. The candidate having completed compulsory rotatory internship within 02 years of date of interview shall be given preference.

Pay Scale:- As per pay matrix of level 10 (Rs.56,100 – 1,77,500/-) plus allowances as admissible under the rules.

Age:- 30 yrs for General [5 yrs relaxable for SC/ST, 3 yrs relaxable for OBC and 5 yrs extra relaxable for Persons with disabilities (Divyangjan) candidate] as on date of interview.

Tenure:- The maximum tenure of **junior resident is for a period of one year only** including any service rendered as junior resident earlier on ad-hoc /regular basis in any recognized institution. The appointment will be initially for 44 days that can be extended further upto a maximum period of 1 yr(with 01 day break after every 44 days) subject to satisfactory work and conduct report from concerned Incharge or till the regular candidate joins whichever is earlier.

In case of non availability of fresh candidates, as per the relevant scheme, candidates may be considered in terms of relaxation of provision as per circular no. F121/26/2010/H&FW/1996-2045 dated 10.6.2011 of Deptt of H&FW, GNCT of Delhi with the following relaxation:-

1. Upper age limit for eligibility for JR will be 40 years.


2. In case of non availability of fresh candidates, the candidates who have completed 01 year of junior residency may also be allowed to appear in the interview as fresh candidates.
3. Separate merit list would be prepared for the candidates who have completed their residency of 01 year.
4. Firstly the list containing the names of the fresh candidates would be exhausted for the appointment and the second list would be used only after that.
5. All appointment of residents from the second list will be for 01 yr only; it would not be renewable after one year.

Other conditions and requirements:-

6. Candidates are required to bring all original certificates and testimonials along with two recent passport size photographs on the date of interview.
7. Appointment shall be subject to medical fitness and verification of certificates.
8. No TA/DA will be paid for appearing in the interview.

Submission of application:- Interested candidates may report for registration at 09:30 AM till 11:30 AM in establishment branch along with photograph, photocopies of qualifying certificates, date of birth proof, Photo ID card and address proof. Only those candidates whose registration is completed by 11:30 AM shall be eligible for appearing before interview board. The interviews will be held thereafter. All original certificates must be brought for verification.


