INTERVIEW NOTICE

Applications are invited in the prescribed format from eligible candidates to fill up the vacant posts of Senior Residents on ad-hoc basis for a period of 44 days in Dr. Hedgewar Arogya Sansthan, in accordance with order no. F.11/79/Hr-med/2023/112745287/1877-79 dated 03.10.2024 of Health & Family Welfare, Govt. of NCT of Delhi and in accordance with DOPT, Govt. of India OM no. 41034/4/2022-Estt.(Res-I) dated 21.11.2022, under the residency scheme as per below schedule. The candidates are directed to report in the Establishment Branch, DHAS Hospital on the date of interview as given below. Registration of the candidates appearing for interviews will be done from 9:30 am to 11:30 am on the date of interview.

Note:-The candidates selected against the vacant post of Specialist will be appointed on adhoc basis for a period of 44 days extendable upto a maximum period of 03 years (with 01 day break after every 44 days) based on satisfactory work and conduct or till the Non Teaching Specialist candidate joins whichever is earlier.

Qualification:- MBBS with post graduate Degree/Diploma/DNB in the concerned specialty from a recognized University/ Institution and should have a valid registration with Delhi Medical Council and the candidate must not have completed 03 years Senior Residency in any recognized institution including regular and ad-hoc period. In case of non availability of PG candidates, minimum 03 years experience in concerned specialty may be considered as per residency scheme. However such candidates will be appointed on adhoc basis for 44 days extendable upto 03 years or till the candidate with PG degree/diploma/DNB are available, whichever is earlier.

Eligibility for SR Casualty:-

1. MBBS with post graduate Degree/Diploma/DNB as per residency scheme in the specialty of Anesthesia/Medicine/Surgery/Ortho etc. from a recognized University/Institution.
2. If above are not available, Degree/Diploma in Family Medicine/Respiratory Medicine may be considered.
3. If above are not available, Candidates who have completed three years of residency for degree/diploma in concerned specialty and awaiting results may be considered.
4. If above are not available, MBBS with 02 years experience (preferably from Govt. Hospital) should be in mentioned specialty i.e Anesthesia/Medicine/Surgery/Orthopaedics/Family Medicine/Respiratory Medicine/Emergency Medicine/Casualty etc. may be considered.

Pay scale:- -As per Pay matrix of Level 11 (Rs.67,700 - 2,08,700/-)plus allowances as admissible under the rules

Age:- 45 yrs for General [5 yrs relaxable for SC/ST, 3 yrs relaxable for OBC and 5 yrs extra relaxable for Persons with disabilities (Divyangjan) candidate] as on date of interview.

Tenure: - The appointment will be initially for 44 days that can be extended further upto a maximum period of 3 yrs (with 01 day break after every 44 days) subject to satisfactory work and conduct report from concerned Incharge or till the regular recruitment is done by Centralized Recruitment Committee, H & FW deptt., Maulana Azad Medical College, Govt. of NCT of Delhi, whichever is earlier. The total tenure of senior residents is for a period of 3 yrs including any service rendered as senior residents earlier on ad-hoc /regular basis in any recognized institution.

In case of non availability of fresh candidates, as per the relevant scheme, candidates may be considered in terms of relaxation of provision as per circular no. F121/26/2010/H&FW/1996-2045 dated 10.6.2011 of Deptt of H&FW, GNCT of Delhi with the following relaxation:-

- 1) In case of non availability of fresh candidates, the candidates who have completed 3 yrs of senior residency may also be allowed to appear in the interview as fresh candidates.
- 2) Separate merit list would be prepared for the candidates who have completed their residency of 3 yrs.
- 3) Firstly the list containing the names of the fresh candidates would be exhausted for the appointment and the second list would be used only after that.
- 4) All appointment of residents from the second list will be for 01 yr only; it would not be renewable after one year.

Other conditions and requirements:-

- 5) The services of SR will be governed by residency schemes of Govt. of India Civil services (Temporary Rules).
- 6) Candidates are required to bring all original certificates and testimonials along with two recent passport size photographs on the date of interview.
- 7) Appointment shall be subject to medical fitness and verification of certificates.
- 8) No TA/DA will be paid for appearing in the interview.

Submission of application: - Interested candidates may report for registration at 09:30 AM till 11:30 AM in establishment branch along with photograph, photocopies of qualifying certificates, date of birth proof, Photo ID card and address proof. Only those candidates whose registration is completed by 11:30 AM shall be eligible for appearing before interview board. The interviews will be held thereafter. All original certificates must be brought for verification.
