3. Internship: Must have completed internship on or after 11.08.2024 (Candidates who have completed internship earlier than 11.08.2024 are not eligible) Candidates have not completed one year of Junior Residency in any recognized institution including regular & adhoc period.
4. MBBS Degree along with marks sheets and attempt certificate.
5. Experience certificate, if any.
6. Undertaking by the candidate to the effect that information given is true to the best of his/her knowledge and nothing is concealed.
7. Age limit below 30 years.

OTHER CONDITIONS OF APPOINTMENT

1. The hostel accommodation is compulsory for JRs, subject to availability.
 2. No TA/DA Will be paid for appearing in the interview.
 3. DMC Certificate should be submitted within 02 week of joining, failing to which may terminate the service
