NOTICE

GIPMER, Govt. Of NCT of Delhi intends to engage Retired Government Servants as Consultants, purely on Contract basis against the vacant posts of paramedical/Technical Staff in this institute.

1. The engagement of retired Government servant as Consultant shall be against a vacant sanctioned post. The engagement of consultant shall be on full-time basis and they would not be permitted to take up any other assignment during the period of consultancy;
2. The engagement of consultant shall initially be for a period of one year. However, it can be extended further subject to the satisfactory performance of the consultant and depending upon the specific job and the time frame for its completion. The total period of engagement as consultant shall not exceed 3 years. In no case the consultant shall be allowed beyond five years. The maximum age limit of engagement as consultant shall be 65 years;
3. The amount of monthly consolidated remuneration / fee in the case of retired Government officials appointed as Consultants shall be Last Pay minus Basic Pension plus DA at the applicable rate, However, a retired Government official appointed as Consultant shall continue to draw pension and the dearness relief thereon during the period of his engagement as Consultant. His/her engagement as consultant shall not be considered as a case of re-employment;
4. The Consultants shall not be entitled to any allowance such as House Rent Allowance, reimbursement of call charges of Residential Telephone / mobile, Transport facility, Residential Accommodation, Personal Staff, etc.
6. No Government vehicle shall be provided to the Consultants,
7. No TA/DA shall be admissible for joining the assignment or on its completion. Consultants will not be allowed foreign travel at Government expense However, Consultants shall be allowed TA/DA for their travel inside the country in connection with the official work, if any, as per their entitlement as on the date of retirement;
- 8 Consultants shall be eligible for 8 days' leave in a calendar year on pro-rata basis. Therefore, a consultant shall not draw any remuneration in case of his/her absence beyond 8 days in a year (calculated on pro-rata basis). Also unavailed leave in a calendar year cannot be carried forward to next calendar year,
9. The engagement of consultants is of a temporary nature and the engagement can be cancelled at any time by the institution concerned without assigning any reason; and

10. Before engaging any retired Government servant as consultant, the GIPMER shall ensure that the retired official is clear from vigilance angle and moot a proposal with full justification to seek the prior concurrence of Finance Department and thereafter the approval of the competent authority.

11. The willing retired Govt. Servant having the eligibility criteria are requested to submitted the prescribed Application Form (Annexure-1). The applications should reach in the Admin Branch GIPMER, before the last date of Submission of application. The last date of Submission of application is 17.05.2026. No application will be entertained after the last date. Application will be submitted along with below mentioned self-attested documents:

- a) Duly filled application form (Annexure-1)
- b) Latest Passport Size Photograph-2
- c) Last pay Certificate
- d) Adhar card/Pen Card/Passport or any other Govt. Id-card
- e) Educational Qualification Certificates
- f) Copy of Retirement Order/PPO

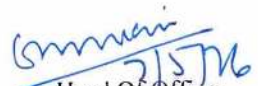
12. The engagement of retired Govt. Servant would be on fulltime basis and they would not be permitted to take up any other assignment during the period of engagement. The engagement is of a temporary nature and the engagement can be terminated at any time by the Department at any point of time without assigning any reason thereof. Specified when a regular or outsource incumbent available the engagement will be terminated with a notice period of 7 days on either side.

13. The engagement will be done, as per the requirement of the Department, after screening the application or through interview, as the case may be.

15. The engagement of retired Technical Staff shall be subject to sound health and subsequent approval of the Competent Authority under GNCTD.
