NOTICE FOR RECRUITMENT OF JUNIOR RESIDENT (DENTAL) PURELY ON ADHOC BASIS

A walk in interview for engagement of Junior Residents (Dental) on adhoc basis is scheduled to be held in IGH, Dwarka on 06.06.2025 (Friday) with vacancy status as follows:-

All eligible candidates who are interested for the same are requested to report at 09:30 AM on 06.06.2025 at 5th Floor, Seminar Room, Admn. Block, Indira Gandhi Hospital, Dwarka along with duly filled performa annexed with this notice, a set of self-attested copies of all certificates, marksheets and two passport size photographs. Original certificates/documents are also required at the time of interview for verification. Candidate's reporting after 11:00 AM will not be considered for the interview.

Only those candidates are required to report who fulfill the eligibility criteria as Residency Scheme and following criteria.

- 1. Qualification: BDS Degree from recognized University/Institute. Must not have completed one year Junior Residency in any Govt. Institute/Hospital in India on Regular or Adhoc basis.
- 2. **Age Limit:** For General Candidates 30 years as on date of interview relaxable for OBC (Delhi) by 03 years (OBC (Delhi only)
- 3. Internship: Must have completed one year rotatory internship after completion of BDS as on or after 05.06.2023.
- 4. Registration: Candidates must have valid registration certificate of DDC/State Dental Council as on date of interview. Applications forms without DDC/State Dental Council Registration Certificate or with 'Applied For' status shall not be considered.
- **5. Pay Scale:** The pay matrix of Level 10 (Rs. 56100-177500), plus other usual allowance as admissible under the residency rules.
- 6. Tenure: The tenure of Junior Resident is purely on adhoc basis initially for a period of 89 days and extendable upto maximum of one year subject to satisfactory work conduct report and vacancy, including any service rendered as Junior Residency earlier on adhoc/regular basis in any recognized government institution.

GENERAL TERMS AND CONDITIONS

- 1. Number of the vacancies may vary.
- 2. OBC certificate issued from Govt. of NCT of Delhi shall only be accepted.
- 3. OBC candidate must have non-creamy layer certificate issued by Govt. of NCT of Delhi of current Financial Year (2025-2026).
- 4. Outside Delhi OBC candidates will be considered in the UR Category.
- 5. In case of OBC certificate reveals that the claim to belong to these categories is fake/false the services will be terminated forthwith without assigning any further reason and without prejudice

to such further action as may be taken under the provisions of Indian Penal Code for production of fake/false certificate

- 6. Benefit of reservation will be granted only on the basis of caste certificate issued by the competent authority and production of original certificate.
- 7. Reservation of PH Category as per rule.
- 8. Selection/appointment is purely on provisional basis, subject to verification of educational certificates and other related certificates/antecedents/DDC certificate and the candidate being found medically fit.
- 9. The service condition will be regulated as per the rules in the Residency Scheme, Ministry of Health & Family Welfare, Govt. of India.
- 10. Candidates if working must produce NOC from present employer.
- 11. NO TA/DA will be paid to the candidates called for the interview.
- 12. In case of number of applications are very high the interview may be continue on the next day.
- 13. Selected candidates shall be allowed to join within 07 working days from the issue of the offer letter failing which the offer shall stand automatically cancelled. No request for extension for joining will be considered.
- 14. Mode of selection will be through interview only.
- 15. In case of any inadvertent error detected at a later stage the same will be rectified as per rules.
- 16. Competent Authority reserves the right of any amendment or cancellation of the advertisement at any stage.
- 17. Competent Authority reserves right to decide in case of any dispute with regard to selection process.
- 18. In case of any Legal dispute, the jurisdiction of Court will be Delhi/New Delhi only.
- 19. No correspondence or personal inquiries shall be entertained.
- 20. Canvassing in any form is liable to the candidate being barred from selection.


