1. **Qualification:** MBBS degree from a recognized University. Valid registration with Delhi Medical Council. Must not have completed one year Junior Residency in any recognized institution including regular & adhoc period.
2. **Internship:** The candidate should have completed compulsory rotating internship after 03.05.2024.
2. **Pay scale:** Rs.56100 – 177500 of level 10 plus allowances as admissible under the rules.
3. **Age limit for Junior Residents:** 30 years for Gen, 35 years for SC/ST, and 33 years for OBC candidates on the closing date of submission of application.
4. In case of non-availability of fresh candidates, the candidates who have completed 01 year of Junior Residency may also be allowed to appear in the interview.
5. **Other conditions/requirements:**
 1. OBC/EWS certificate issued by Govt. of NCT of Delhi shall only be accepted and the same must have been issued before the date of interview. Further, the OBC certificate must possess Non Creamy Layer certificate for the current year along with his/her caste certificate.
 2. Candidates are required to bring all original certificates and testimonials along with two passport size photographs on the date of interview.
 3. No TA/DA will be paid for appearing in the interview.
 4. Hostel accommodation is mandatory for selected candidates subjected to availability.
 5. Number of the vacancies is provisional and subject to change without any notice.
 6. In case of non-availability of candidates under SC/ST/OBC/EWS category, vacancies may be filled up from the General category.
 7. In case of SC/ST/OBC/EWS certificate reveals that the claim to belong to these categories is fake/false, services will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under the provisions of Indian panel code for production of fake/false certificate.
 8. All appointment shall be subject to medical fitness by the medical board of JPCH and verification of certificate of education qualification/age/caste/submission of valid DMC registration certificate and internship completion certificate etc.
