1. **Qualification:** BDS degree from a recognized University.
2. **DDC Registration:**
 - Candidates must be registered with Delhi Dental Council at the time of submission of application.
 - The candidates must be applied for with Delhi Dental Council at the time of submission of application.
 - Candidates registration with State Dental Council other than delhi shall not be allowed for interview.
3. **Selection Procedure:** The selection of candidates shall be based on a Written Examination followed by an Interview. Only those candidates who secure atleast 50% marks in the Written Examination, shall be called for the Interview. The final selection shall be made on the basis of the criteria approved by the Competent Authority.
4. **Internship:** The candidate should have completed compulsory rotating internship after 06.08.2024.
5. **Pay scale:** Rs.56100 – 177500 of level 10 plus allowances as admissible under the rules.
6. **Age limit for Junior Residents:** 30 years on the closing date of submission of application.
7. In case of non-availability of fresh candidates, the candidates who have completed 01 year of Junior Residency may also be allowed to appear in the interview.
8. **Other conditions/requirements:**
 - Candidates are required to bring all original certificates and testimonials along with two passport size photographs on the date of interview.
 - No TA/DA will be paid for appearing in the interview.
 - Hostel accommodation is mandatory for selected candidates subjected to availability.

- All appointment shall be subject to medical fitness by the medical board of JPCH and verification of certificate of education qualification/age/submission of valid DDC registration certificate and internship completion certificate etc.

- **JRs are appointed for the 89 days tenure period extendable to maximum of 01 year, including previous experience, if any or till the regular candidate joins, whichever is earlier.**
