

Terms & Conditions

- Janakpuri Super Speciality Hospital is an Autonomous Institute and is registered as a Society under the Society Act under the Government of NCT of Delhi. The Service in the Institute is governed by the Memorandum of Association (MoA) of the Society and the Rules & Regulations framed there under.


2. The appointment of teaching faculty shall be on contract basis for a period of 03 years and extendable further for another 02 years (i.e. total contract period is maximum 05 years) after assessment on the basis of annual performance report.
3. The appointment of Deputy Medical Superintendent, Specialists and Medical Officer shall be initially on contract for a period of five years with a notice period of three months from either side for severance of contract. Further extension will be based on annual performance appraisal report upto the age of superannuation in the Government of NCT of Delhi.
4. The emoluments for the post of Deputy Medical Superintendent will be as per revised pay rules Level 13 (Pay Rs. 1,23,100/- plus admissible allowances per month) and as per rules approved by the Governing Council of JSSHS.
5. The Post of Professor will carry consolidated remuneration of Rs. 3,05,000/- [Rupees three lacs five thousand only] per month (Inclusive of all allowances).
6. The Post of Associate Professor will carry consolidated remuneration of Rs. 2,55,000/- [Rupees two lacs fifty five thousand only] per month (Inclusive of all allowances).
7. The Post of Assistant Professor will carry consolidated remuneration of Rs. 1,95,000/- [Rupees one lac ninety five thousand only] per month (Inclusive of all allowances).
8. The emoluments for the post of Specialist Grade – III will be as per revised pay rules Level 11 (Pay Rs. 67,700/- plus admissible allowances per month) and as per rules approved by the Governing Council of JSSHS.
9. The emoluments for the post of Medical Officer will be as per revised pay rules Level 10 (Pay Rs. 56,100/- plus admissible allowances per month) and as per rules approved by the Governing Council of JSSHS.
10. The Competent Authority reserves the right to alter/cancel the number of posts at any stage or to withdraw the process, in full or in part. The Competent Authority also reserves the right to reject any or all applications received without assigning any reasons or giving notice etc. Any corrigendum will be published only on the website of the hospital and Department of H&FW, GNCTD.
11. The application should be accompanied by caste certificate for applying under the Other Backward Classes/Scheduled Caste/Scheduled Tribe (OBC/SC/ST) category. In the OBC category, only OBC candidates of Delhi will be eligible and the OBC certificate should be issued by the Competent Authority of Govt. of NCT of Delhi. The OBC candidate is also required to submit a certificate of “not belonging to the Creamy Layer”, issued by the Competent Authority in conjunction to the OBC certificate. The certificate of “not belonging to the Creamy Layer” should have been issued within three months before the last date of submission of application. In the SC/ST category, the certificate should be issued by competent Judicial/Revenue authorities. The appointment under OBC/SC/ST category will be provisional and subject to the caste certificate being verified through the proper channels. If the verification reveals that the claim of belonging to OBC/SC/ST (as the case may be) or for not belonging to Creamy Layer in OBC is fake/false, the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of Indian Penal Code for production of fake/false certificate (as per DOPT OM No. 36033/4/97-Estt (Res) dated 25 July 2003).
12. Application fee (Non refundable) of Rs. 1000/- for Unreserved, and Rs. 500/- for OBC/SC/ST candidates shall be paid through **POS machine (through Credit/Debit Card only)** available at **Accounts Branch, 1st Floor, JSSH.**
13.  16. Candidates should also enclose 'Work & Conduct' and 'Vigilance Clearance Certificate' from their previous employer at the time of interview.

The date, time and venue for interview will also be displayed on the website of Department of Health & Family Welfare of Govt. of NCT of Delhi (www.health.delhigovt.nic.in) under the link "Vacancy & Result". No separate call letters will be issued for interviews. Candidates should report one hour before the time of interview. No TA/DA shall be paid for appearing in the interview.
 22. The candidates while appearing for interview will need to produce all relevant original documents along with one attested photocopy each of all testimonials/certificates and one passport size photograph.
 23. Any canvassing by or on behalf of the candidate or exercise of any outside influence in any form with regard to selection will lead to disqualification of candidate.
