NOTICE FOR INTERVIEW TO FILL THE POSTS OF SENIOR RESIDENT ON AD-HOC BASIS.

WALK-IN-INTERVIEW will be conducted on the date and time mentioned in the table below to fill vacant posts of Senior Residents on Ad-hoc basis for the period of 44 days.

Vacancy may be changed as per actual position at the time of interview.

Eligibility:-

(i) **Essential Qualification:-** MBBS with Post Graduate Degree/DNB/Diploma or Post-Doctoral Degree (or equivalent, in the concerned specialty in from an NMC/MCI recognized University/Institute and must possess DMC registration for the concerned specialty/super specialty. The tenure of the PG Degree/DNB/Diploma or post Doctoral Degree or equivalent should be complete as well as the result also should be declared before the date of interview.

(ii) If, MBBS with Post Graduate Degree/DNB/Diploma or Post-Doctoral Degree or equivalent, candidate is not available then candidate with MBBS degree with 2 (Two) Years experience in the same specialty can be considered.

(iii) **Age Limit:-** Certificate of age proof (age limit as on the date of interview - 45 Years for General candidate, EWS & 03 years relaxation OBC certificates (non creamy layer). 05 years relaxation in case of SC/ST. OBC certificate issued from Govt. NCT of Delhi only will be considered.

(iv) **Relaxation of Criteria:-** In accordance with circular No. F. No. 121/26/2010/H&FW/1996-2045, dated: 10-06-2011 issued by Health & Family Welfare Department, Govt. NCT of Delhi, the following relaxation shall be applicable in case of **non- availability of fresh candidates:-**

(iv-a) In the specialties where there is perpetual shortage like Radiology, Anesthesia, etc or in specialties where no fresh candidates are available, candidates who have completed 03 years Senior Residency but are willing to serve as Senior Residents will also be allowed to appear in the interview.


(iv-b) Separate merit lists for fresh candidates and for others (those who have completed 03 years of residency) will be prepared.

(iv-c) In the first place, the list containing names of fresh candidates will be exhausted for appointment as Senior Residents and the second list will be taken up only thereafter.

(iv-d) All appointment for Senior Residents from second list will be for a maximum period one year only.

1. **EMOLUMENTS:-** As per 7th CPC, Pay Matrix Level 11 (Rs. 67,700 – 2,008,700) and other admissible allowances per month.
2. **TENURE:-** The tenure of Senior Residents will be for a period of 44 days which can be extended for further 44 days by giving 01 day break after receiving written request from the concerned doctor which is duly recommended & forwarded by the concerned HOD or till regular incumbents join whichever is earlier (maximum 03 years including any service rendered as Senior Residents earlier on ad-hoc/regular basis in any NMC recognized teaching/ non teaching institution) in accordance with the Residency Scheme of GOI dated: 05-06-1992 and subsequent extended Residency Scheme notified vide circular No. F. No. 121/26/2010/H&FW/DSHFW/1996-2045 dated: 10-06-2011.
3. No NOC of any kind will be issued to the SR before the candidate has put in at least 44 days of continuous service.
4. No permission/leave will be granted to attend conference/seminars/workshops/fellowship programme of more than three days duration at any given date during the tenure of residency in the hospital.
5. There is no fee for appearing in the interview and Candidate must bring either DMC registration or provisional DMC registration.
6. Interested and eligible candidates may apply in the prescribed application format alongwith original & self attested photocopies of the requisites (i.e. MBBS Degree, Post Graduate Degree, DMC Certificate of DMC registration or acknowledgement of PG Degree, Caste Certificate and Proof of awards/Publications, if applicable & Identity Proof viz. Aadhar Card, Voter ID Card, Driving License, Passport etc.) alongwith 2 (two) Photographs should be submitted between 9:30 AM to 10:30 AM to Administration Branch LBSH. No application will be entertained beyond stipulated time. However, the candidate, only who have DNC (with PG Degree) or applied for registration with DMC (with PG Degree) and have enclosed acknowledgement of DMC will be allowed to appear in the interview provisionally.
7. In case of number of applications are very high, the interview may be continued on the next working day. The same will be informed to the candidates verbally by Board Members on the date of Interview at the closing time. Therefore, candidates who are not interviewed on the said date shall not leave the place of interview, without the knowledge of Board Members. No separate communication will be made in this regard.
8. The candidates are advised to visit the following website of Department of Health & Family Welfare, GNCTD. For the result.
9. No separate information or call letter will be issued for the same.
10. Candidates must produce NOC from present employer.
11. No TA/DA will be paid to the candidates called for the interview.
12. Selected candidates shall be allowed to join within 07 days of issue of the offer letter failing which the offer shall stand automatically cancelled. No extension for joining will be considered.
13. Selected Candidate will be taken on strength only after production of DMC certificate within one month from date of joining.

14. Mode of selection will be through interview only. Rank list will be prepared and same will be valid till next interview notice published.
15. In case of any inadvertent error detected at a later stage, the same will be rectified as per rules.
16. Competent Authority reserves the right of any amendment or cancellation of the interview.
17. Competent Authority reserves the right to decide in case of any dispute with regard to selection process.
18. The selected candidates can be posted anywhere in patient care/ public interest in emergency.
