ELIGIBILITY for Senior Residents:-

1. **Qualification:-** Post Graduate Degree (MD/MS/DNB/DIPLOMA equivalent) in concerned specialty.
2. **Age Limit:-** For S.R. -45 years for General, 50 years for SC/ST and 48 years for OBC (Delhi) Candidates (as on date of interview).
3. Basic of Rs. 67700/- in Revised Pay Matrix 11 of 7th CPC & other allowances as admissible.
4. No separate letter for interview will be issued. No TA/DA will be paid for appearing in interview.
5. Candidates must bring Original Certificates & submit their Application along with self attested copies of certificate at the time of interview.
6. If candidates of reserved category not appeared for interview than seat may be filled from other categories as per reservation policy.
7. The candidates who have completed three years Senior Residency but are willing to serve as Senior Resident can also apply and will be offered residency only if no fresh Senior Residents are available. However, their appointment will be for a period of 89 days extendable up to a maximum period of one year only.

NOTE- The services of Adhoc SRs' are likely to be terminated upon joining of Regular SRs through Govt. of NCT of Delhi or Regular interview of SRs' even if the tenure of 89 days is not completed.
