**Eligibility**

(a) **For JR:-** MBBs degree from MCI/NMC recognized university/Institute with internship completion certificate

(b) **Internship:-** Registration with DMC is compulsory. Internship must be completed between **13.05.23 to 13.05.25**

(c) **Emoluments:-** For JR Rs. 56,100/- in level 10, plus usual allowance as admissible under the rules.

(d) **Age Limit:-** As on 14.05.25 shall be 40 years for Genral candidates, 45 years in case SC/ST and 43 years in case of OBC candidate in accordance of circular No. F.No.121/126/2010/H&FW/1996-2045 dated 10/06/2011 issued by H&FW Department of NCT of Delhi.

(i) PG Doctors who are interested serve as JR will be allowed to join as JR if fresh graduates are not available.

(ii) **Second list:-** JR. Residents who have completed 01 year of Jr. Residency shall also be allowed to appear in the interview and will be offered residency only if fresh Jr. Residents are not available. There would be no extension for any Jr. Resident beyond 01 year of appointment. JR needs to submit an undertaking for the time period they have served in Delhi Govt. Hospital



Tenure:- Appointment will be initially for a period of 89 days extendable on the basis of satisfactory work & conduct report from the concerned incharge and written request from the Doctor concerned.

**CONDITION FOR RECRUITMENT:-**

- A. All the eligible candidates should report in the office of the undersigned at 9.30 A.M (time for enrollment from 9.30 A.M to 10.30 A.M only) on the day of interview.
- B. For candidate applying for OBC category the certificate must be issued by the competent authority of Govt. of NCT of Delhi. The OBC candidate must be in possession of non-creamy layer certificate for current year.
- C. Person with disabilities shall be given relaxation as per rule
- D. The number of vacancies may vary.
- E. No TA/DA will be given for appearing in the interview.
- F. Candidate must submit their bio-data with attested photocopy of certificates and original documents should be shown at the time of interview
