
Emoluments for SR:- Pay matrix of level 11 (Rs. 67700-208700) other usual allowances as admissible under the rules.

Date & time of Interview:- 06/02/2026 at 11.00 A.M onward on the mentioned date, Candidates must report on time so that there is no delay In interview.


CONDITION FOR RECRUITMENT:-


- F. Candidate must submit their bio-data with attested photocopy of certificates and original documents should be shown at the time of interview
