Notice for walk in interview for the post of senior resident on ad-hoc basis

A walk in interview for appointment to the post of Senior Resident in the following Departments is called which is purely on ad-hoc basis for a period of 89 days or till regular candidate joins, whichever is earlier, extendable up to a maximum period of 03 years provided with the condition that the service rendered has been found 'satisfactory'. The interview will be conducted in the conference room (Room No.103) of this hospital for which the registration time is from 09:00 AM to 11:00 AM.

The posts are to be filled up on Ad-hoc basis on first comes first serve basis and strictly on merit basis.

Eligibility Criteria for the post of Senior Resident:-

- Qualification:-**
MBBS with Post Graduate Degree/Diploma from a recognized University and registered with the Delhi Medical Council (as per Residency Scheme).
- Age Limit:-**
Maximum age shall be 45 years as on the date of interview, as per Order No. F.DHF&W/Q015/57/2016-HR-Medical-Secy(H&FW)/11245062/1502/08 dated 26.11.2020 issued by the Health & Family Welfare Department, GNCTD. Age relaxation for reserved category candidates shall be admissible as per rules.
- Pay Scale:-**
Pay Matrix Level-11 (Rs. 67,700 – 2,08,700) plus other admissible allowances as per rules.
- Registration:-**
Candidates must possess a valid registration certificate with the Delhi Medical Council.
- Verification of Documents:-**
Appointment shall be subject to verification of educational qualifications, age proof, address proof, caste certificate, DMC registration and other relevant documents.

6. Relaxation in Eligibility:-

In case of non-availability of candidates as per the relevant Residency Scheme, candidates may be considered under relaxed norms as per Circular No. F. No. 121/26/2010/H&FW/1996-2045 dated 10.06.2011 issued by the Health & Family Welfare Department, GNCTD, subject to the following conditions:-

- i. Candidates who have completed three years of Senior Residency and possess a Postgraduate qualification may also apply under the relaxed eligibility norms. However, for the post of Senior Resident (Medicine), candidates who have either completed three years of Senior Residency or possess a Postgraduate qualification may also apply under the relaxed eligibility norms.
- ii. A separate merit list shall be prepared for candidates who have completed 03 years of Senior Residency.
- iii. Preference shall be given to fresh candidates. Candidates under relaxed norms shall be considered only after the merit list of fresh candidates is exhausted.
- iv. Appointments made from the second merit list shall be for a period of one year only and shall not be renewable thereafter.

7. Application Fee:-

No fee shall be charged for appearing in the interview.

8. Reservation:-

Reservation for Persons with Disabilities (PwD)/Differently Abled candidates and EWS candidates shall be applicable as per Government rules.

9. TA/DA:-

No TA/DA shall be paid for appearing in the interview.

10. Hostel Accommodation:-

Hostel accommodation shall be provided to Senior Residents, subject to availability and upon request. In the event of allotment of hostel accommodation, deductions shall be made from the pay as per the prevailing rules and regulations of the Institute.

11. Eligibility:-

Candidates are advised to ensure that they fulfill all eligibility criteria before appearing for the interview.

12. Joining:-

Selected candidates shall be required to join immediately or within 07 days from the date of issue of the offer letter, failing which the offer shall stand cancelled automatically. Therefore, only those candidates who can join immediately are advised to apply.
