2. ELIGIBILITY CRITERIA FOR THE POST OF SENIOR RESIDENTS -

A. Qualification:-

(i). MBBS with Post Graduate Degree/ DNB/ Diploma as per residency scheme in the concerned specialty from a recognized University/ Institution.

B. Age :- Below 45 years, **On Date of Interview**, as per order No.F.DHF&W/Q015/57/2016-HR-Medical-secy(H&FW)/CDNo.112425062/1502-08 dated 26.11.2020.

C. Pay:- Basic of RS. 67700/- in pay Matrix 11 of 7th CPC with other allowances as admissible per month.

D. Must be registered with Delhi Medical Council.

E. Appointment will be initially for a period of 89 days or till regular joins or till SR appoints through the Centralized Appointment committee of SR/JR, whichever is earlier and may be extended beyond 89 days maximum upto 03 years on the same conditions based on work and conduct report.

F. Appointment will be subject to medical fitness and verification of certificate of educational qualification/age/caste/DMC registration and internship completion certificate etc.

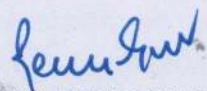
G. Candidate must not have completed three year senior residency from any Govt.Hospital(*)

(*) **Further in case of non-availability of candidates**, as per the relevant scheme mentioned above, candidates may be considered in terms of relaxation of provision as per circular No. F.No. 121/26/2010/H&FW/1996-2045, dated 10.06.2011 issued by Health & Family Welfare Department, Govt. of NCT of Delhi with the following relaxation.

1. In the Specialties where no fresh candidates are available, candidates, who have completed 3 years of Sr. Residency, may also be allowed to appear in the interview.
2. Separate merit list would be prepared for the candidates who have completed their residency of 3 years as SR.
3. Firstly the list containing name of fresh candidates would be exhausted for appointment as SR and the second would be used only after that.
4. Further, all senior Resident appointment from second list will be for one year only (based on the mentioned T&C) for those who have already completed 3 years of Residency. It would not be renewable after one year.

H. CONDITION FOR RECRUITMENT –

- A. All the eligible candidates should report in the office of the undersigned at 9.00 A.M.[Time for enrollment from **9.00 A.M. to 10.30 A.M. only**] on the day of interview.
- B For candidates applying for OBC category, the certificate must be issued by the competent authority of Govt. of NCT of Delhi along with the current F.Y. Non creamy layer certificate. Persons with disabilities shall be given relaxation as per rule.
- C The number of vacancies may vary.
- D No TA/DA will be given for appearing in the interview.
- E Candidate must submit their Bio-Data with attested photo copy of certificates and original documents should be shown at the time of interview. OBC certificate (along with current NCL) should be issued by the GNCTD only & applicable for Delhi only for the current F.Y.
- F Candidates are advised to ensure that they fulfill the eligibility criteria as mentioned in the advertisement before appearing in the interview.
- G Other services conditions will be applicable as per service condition prescribed from time to time by the Govt. of NCT of Delhi.
- H The decision of the selection board regarding selection will be final and binding and no representation will be entertained in this regard.
- I The services of S.R. will be Governed by Residency Scheme of Govt of India/ Civil Services (Temporary Rules.).

Eligibility for Junior Resident:

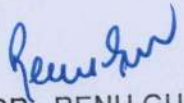
- 1.) MBBS Degree from a NMC recognized university/Institute with internship completion certificate. Foreign Graduates must have cleared FMG Examination. The candidate must not have done junior residency of one year from any recognized institute.
- 2.) **Candidates must possess valid Delhi Medical Council registration on the date of interview. Candidates who have applied for DMC will not be allowed to appear in the interview on the basis of acknowledgement slip.**
- 3.) Must have completed rotating internship by the date of interview.
- 4.) Age limit is upto 30 years for Gen., 35 years for SC/ST candidates and 33 years for OBC candidates on the date of interview. Further upper age limit for persons with disabilities shall be relaxable by 10 years.
- 5.) **Internship completed not before 02 years of date of interview.**

Conditions of Recruitment:

- 1.) Appointment will be initially for a period of 89 Days, which may be extended maximum upto 01 year or till regular joins or till recruitment is done by the Centralized recruitment committee for SR/JR, whichever is earlier, subject to work and conduct report of the concerned HOD and approval of the competent authority.
- 2.) Appointment will be subject to verification of certificate of Educational Qualification/Age/DMC registration and internship completion certificate etc.

- 3.) OBC candidates are required to submit their caste certificate (issued before the date of application) along with current Non-Creamy Layer certificate issued by the Govt. of NCT of Delhi only (for the current financial year). The certificate should be issued for Delhi specifically.
- 4.) The services will be governed under Residency Scheme of Govt. of India.
- 5.) If any declaration/information furnished by the candidates is found false or any material/fact suppressed willfully, the candidate/appointment will be cancelled/terminated forthwith.
- 6.) The decision of the Selection Board/Medical Suptd. SVBPH regarding selection will be final and binding and no representation will be entertained in this regard.
- 7.) Selected candidates shall be allowed to join within 07 days of the issue of offer of Appointment failing which the offer shall stand automatically cancelled.
- 8.) Candidates are advised to ensure that they fulfill the eligibility criteria as mentioned in the notice for Walk in Interview before appearing in the interview.
- 9.) Candidate must submit their Bio-Data with attested photo copy of certificates and original documents shall be shown at the time of interview.
- 10.) No TA/DA & Accommodation for stay in Delhi will be paid / provided for appearing for interview.
