## CORRIGENDUM

Whereas, Order No. F.23/Misc/COVID-19/DGHS/NHC/ 2020/Pt VIII/90-97 dated 12.04.2021 issued by this Directorate wherein 14 private hospitals were declared as full COVID hospital and were directed that henceforth these hospitals shall not admit any non-COVID medical/ surgical patient till further orders.

Whereas, in pursuance to the representations submitted by these private hospitals a meeting was held under the Chairmanship of Hon'ble Minister of Health, GNCTD with the Directors/ Medical Directors/ Chief Operating Officers/ Medical Superintendents of the concerned 14 private hospitals on 14.04.2021.

Whereas, in the said meeting it was decided through consensus that keeping in view the interest of treatment of non-COVID patients and also the alarming rise in the COVID-19 cases in Delhi, the concerned 14 private hospitals would cumulatively provide 3553 beds for COVID related treatment and the remainder beds/ additional beds in these hospital shall be used for treatment of non-COVID follow-up patients and patients requiring emergent medical/surgical treatment. Further, the concerned 14 hospitals would be allowed to temporarily increase their bed capacity upto 35% and the additional beds may also be utilised for treatment of non-COVID patients.

Therefore, Order No. F.23/Misc/COVID-19/DGHS/NHC/ 2020/Pt VIII/90-97 dated 12.04.2021 issued by this Directorate is amended and the revised COVID bed capacity in 14 private hospitals is annexed at Annexure 'R'. The 14 hospitals (listed in Annexure 'R') are required to reserve the requisite number of beds mentioned in Column 'D' of the table in Annexure 'R' exclusively for treatment of COVID-19 patients and the remainder beds may be utilised for the treatment of non-COVID follow-up patients and patients requiring emergent medical/surgical treatment. Further, the 14 hospitals (listed in Annexure 'R') are allowed to temporarily increase their bed capacity upto 35% and the additional beds may be utilised for treatment of non-COVID patients. The revised total COVID bed capacity along with total COVID ICU beds shall be uploaded by the concerned 14 hospitals on COVID-19 Data Management Portal at the earliest.

This issues with the approval of Hon'ble Minister (Health).
