ORDER

In pursuance to Order No. F.23/(413)/GEN/Circular/NHC/DGHS/HQ/5366-77 dated 24.05.2020 issued by Director General of Health Services wherein all 117 nursing homes/private hospitals having bed strength of 50 beds or more were directed to earmark/ reserve at least 20% of their total beds strength for COVID-19 patients & Order Nos. 52/DGHS/PH-IV/COVID-19/2020/prsecyhw/6244-6261; 7323- 7392; 7615-7674 & 9985- 10040 dated 30.04.2020, 09.05.2020; 16.05.2020 & 03.06.2020 issued by Secretary (Health & FW) wherein certain private hospitals were declared as COVID hospitals (wholly or partially) and in continuation of earlier Order of even number dated 14.05.2020.

During the period of pandemic, the identified allopathic private hospitals having a bed strength of 50 beds or more, which were allotted land at concessional rates by land owning agencies and are under an obligation to provide 10% IPD and 25% of total OPD completely free of any charges to eligible patients of EWS category, are directed to earmark/ reserve the following number of beds for EWS patients who are infected with COVID-19 or otherwise:



No. 3155/2017; SLP Nos. 18599/2007 & 29482/2011, respectively and Judgements dated 22.03.2007 & 22.09.2009 pronounced by the Hon'ble High Court of Delhi in W.P. (C) Nos. 2866/2002 & 5410/1997, respectively.

This issues with the prior approval of the competent authority.




