ORDER

Whereas, Order No. F.23/Misc/COVID-19/DGHS/NHC/2020/Pt VIII/10826-10832 dated 31.03.2021 was issued by this Directorate wherein the keepers of 33 private hospitals/ nursing homes were directed to reserve at least 25% of their ICU & Ward bed capacity or double the occupancy of COVID ICU & Ward beds as on 30.03.2021, whichever is higher for COVID related treatment and display the revised COVID bed capacity (Ward & ICU) on COVID-19 data management portal. Subsequently, another Order No. F.23/Misc/COVID-19/DGHS/NHC /2020/Pt VIII/11-17 dated 05.04.2021 was issued by this Directorate where in the keepers of 54 large private hospitals having bed strength of 100 beds or more were directed to reserve at least 30% of their ICU & Ward bed capacity or double the occupancy as on 05.04.2021, whichever is higher for COVID related treatment.

Whereas, the positivity rate in Delhi has increased from 2.71% on 31.03.2021 to 6.10% on 07.04.2021 & number of active cases in Delhi has surged from 8838 on 31.03.2021 to 19455 on 07.04.2021.

Whereas, a meeting was held with the keepers of 54 private hospitals, having beds strength of 100 beds or more, on 07.04.2021 and it was found that the occupancy of COVID ICU beds has surged and reached more than 85% in 20 out of 54 private hospitals. Similarly the occupancy of COVID Ward beds has also increased and reached more than 75% in 22 out of these 54 private hospitals.


Whereas, a meeting was held under the Chairmanship of Hon'ble Minister of Health, GNCTD with senior officers of Department of Health & Family Welfare, GNCTD on 08.04.2021 for reviewing the status of occupancy of COVID ICU & Ward beds in the hospitals of Delhi and it was decided that 115 private hospitals either having total bed capacity of 50 beds and more or already identified & registered for providing COVID related treatment, may be directed to reserve 50% of their total ICU & Ward bed capacity or 1.25 times the occupancy of COVID ICU & COVID Ward beds displayed on COVID-19 Data Management Portal on 08.04.2021, whichever is higher {List of 115 private hospitals along with bed capacity (ICU & Ward) and occupancy of Covid ICU & Covid Ward as on 08.04.2021 is annexed at Annexure 'A'}. Further, these 115 hospitals may be given liberty to reserve more than the aforementioned requisite beds for COVID related treatment.

Furthermore, these 115 hospitals would also be allowed to temporarily increase 25% of their total bed capacity. However, the increased bed capacity is to be exclusively used for COVID related treatment.

Therefore, in order to augment the bed capacity for COVID-19 patients 115 private hospitals either having total bed capacity of 50 beds and more or already identified & registered for providing COVID related treatment are hereby directed to reserve 50% of their total ICU & Ward bed capacity or 1.25 times the occupancy of COVID ICU & COVID Ward beds displayed on COVID-19 Data Management Portal on 08.04.2021, whichever is higher {List of 115 private hospitals along with bed capacity (ICU & Ward) and occupancy of Covid ICU & Covid Ward as on 08.04.2021 is annexed at Annexure 'A'}. Further, these 115 hospitals are given liberty to reserve more than the aforementioned requisite beds for COVID related treatment. Furthermore, these 115 hospitals are also allowed to temporarily increase 25% of their total bed capacity. However, the increased bed capacity is to be exclusively used for COVID related treatment.
