ORDER

Whereas, availability of adequate and uninterrupted supply of Medical Oxygen in hospitals has become an important pre-requisite for combating cases of COVID- 19 in NCT of Delhi,

And whereas, Medical Oxygen is an essential public health commodity and any impediment in its supply may critically impact the management of COVID 19 situation in Delhi.

And whereas, Empowered Group-II, Ministry of Health & Family Welfare, GoI, looking after coordination of medical logistics including Oxygen, has prepared a supply plan for entire country wherein manufacturers have been mapped with various States/UTs for supply of fixed quantity of Oxygen to them,

And whereas, a number of manufacturers including Air Liquide, Panipat; Inox, Bhiwandi; Goyal MG Gases, Ghaziabad etc. have been mandated by Ministry of Health & Family Welfare, GoI vide D.O. letter No. 12011/45/2020-proc-I dated 15/04/2021 to supply fixed quantity of Medical Oxygen to NCT of Delhi,

And whereas, Ministry of Home Affairs vide D.O. letter No. 40-6/2020-DM-I(A)/Pt(2) dated 16/04/2021 has provided that supply plan, as prepared by the Empowered Group-II, Ministry of Health & Family Welfare, GoI, should strictly be adhered to by all States/UTs,

Now, therefore, Sh. Vijay Kumar Bidhuri, IAS is deputed as Officer on Special Duty for ensuring uninterrupted supply of medical Oxygen by manufacturers to refillers in NCT of Delhi. The officer shall ensure that quantity fixed for NCT of Delhi is released/dispatched from the facility without fail. The details of quantity to be provided by each manufacturer on a particular date are appended with this order. After dispatch of Oxygen, he shall submit a report to this effect on daily basis.
