- Candidates, who fulfill the eligibility criteria, may apply in the enclosed prescribed Proforma alongwith attested copies of all testimonials and passport size photographs and submit their forms at **Seminar Hall (Ground Floor), Doctor's Hostel on 18.09.2020 from 9.00 AM to 11.00 AM. Candidates appearing after 11.00 AM will not be considered for Interview.**
- All interested candidates are advised to download the application form **Enclosed** below for appearing in interview. No Application form will be provided at the time of interview. Candidates are required to print pg. 4- 6 for form attached with this advertisement.
- **The date and time of Interview is subject to number of application forms received on the above mentioned date. If required, interview may be continued on next working day for candidates who get enrolled on 18.09.2020 only but did not get time for interview.**

TERMS & ELEGIBILITY CRITERIA FOR THE POST OF JUNIOR RESIDENT :-

- 1 **Qualification:** MBBS or equivalent degree from a MCI recognized university/Institute. Foreign Graduate must have cleared FMG examination. The candidate must not have done junior residency of one year from any recognized institute.
- 2 **Age:-** for General candidates 30 years as on date of Interview (i.e. 14/07/2020). Relaxable for SC/ST by 05 years and for OBC(Delhi only) by 03 years. OBC candidates are required to submit their caste certificate issued by the Competent Authority of GNCT of Delhi. The certificate should mention their belonging to non-creamy layer. Age relaxation for PH candidates is as per rules. Attested copy of Age proof (Class 10th Certificate to be attached.) **However, if fresh eligible candidates as per above criteria are not available, the relaxation as per Circular No. F.No. 121/26/2010/H&FW/1996-2045 dated 10/06/2011 of Government of**

NCT of Delhi shall be admissible and the maximum age limit shall be 40 years, irrespective of category and a separate list will be made to those candidates.

- 3 **Internship:-** Candidate must have completed one year rotatory internship/passed FMG examination on or after 19.09.2019.(i.e. 1 year before date of interview). **In case of sufficient candidates are not available under the 1 year of Internship Criteria, then relaxed category candidates will be considered under the separate list, however they have to completed internship and a valid DMC certificate and maximum age will be 40 years irrespective of category Candidates has to submit DMC certificate.**
- 4 **Registration:** Candidate must have Valid DMC Registration Certificate at the time of Interview. Application with 'Applied For' status are eligible for interview subject to the condition that they have to submit DMC Certificate before joining.
- 5 Junior Residents who have completed one year of Junior Residency**(including those who are working on Adhoc basis in DDU Hospital)** shall also be allowed to appear in the Interview and will be offered residency only if fresh candidates for the post of Junior Residents are not available. There would be no extension for any Junior Resident beyond one year of appointment under relaxed provisions (vide Circular No. 121/26/2010/H&FW/1996-2045 dated 10/06/2011). **In any case, no candidates shall be eligible who already had completed 02 years residency in any government Hospital under the Residency Scheme.**

GENERAL TERMS AND CONDITIONS

1. 3% seats shall be reserved for physically handicapped persons as per the rules.
2. 10% of the unreserved vacancy is reserved for EWS candidates.
3. Number of the vacancies is provisional and subject to change without any notice.
4. Appointment will be initially for a period of six months extendable up to maximum of one year on the basis of satisfactory work & conduct report from the concerned HOD and written request from the Doctor concerned.
5. Pay Scale: As per Pay Matrix, at Level 10 (Rs. 56100-177500), Plus usual allowance as admissible under the rules.
6. *OBC/EWS certificates issued from Govt. of NCT of Delhi shall only be accepted.*
7. In case of SC/ST/OBC/EWS certificate reveals that the claim to belong to these categories is fake/false the services will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under the

provisions of Indian Penal Code for production of fake/false certificate.

8. The appointment and services will be governed under Residency Scheme of Govt. of India.
9. Selected candidates who accepts the offer of appointment and join the hospital will not be given NOC of any kind for any purpose whatsoever (passport,visa,etc.) before putting in atleast 06 months of service.
10. All appointments shall be subject to medical fitness and verification of certificates of educational qualification/age/caste/submission of valid DMC registration certificate and internship completion certificate etc.
11. No TA/DA to be paid to the candidates called for interview.
12. jurisdiction of Dispute: In case of any Legal dispute, the jurisdiction of Court will be Delhi/New Delhi only.
