**2. ELIGIBILITY CRITERIA FOR THE POST OF JUNIOR RESIDENTS [MBBS]:-**

- A. **Qualification:-** MBBS degree from recognized University/Institute.
- B. **Age:-** Age as on 10.06.2019 shall be **30 years** for General candidates, **35 years** for SC/ST and **33 years** for OBC candidates, in accordance with circular No. F.No.121/26/2010/H&FW/1996-2045, dated 10.06.2011 issued by Health & Family Welfare Department, Govt. of NCT of Delhi.
- C. **Pay:-** Basic of **Rs. 56100/-** in Pay Matrix 10 of 7<sup>th</sup> CPC with other allowances as admissible per month.
- D. **Internship:-** Must have completed internship **after 20.09.2018**.
- E. Must be registered with Delhi Medical Council.
- F. Appointment will be initially for a period of six months extendable up to maximum of one year on the basis of satisfactory work & conduct report from the concerned HOD and written request from the doctor concerned.
- G. **Appointment will be subject to medical fitness and verification of certificate of educational qualification/age/caste/DMC registration and internship completion certificate etc.**
- (\*) **Further in case of non availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of relaxation of provision as per circular No. F.No.121/26/2010/H&FW/1996-2045, dated 10.06.2011 issued by Health & Family Welfare Department, Govt. of NCT of Delhi with the following relaxation:-**
- a) Upper age limit for eligibility will be 40 years, in place of existing 30 years of age.
- b) PG Doctors who are interested to serve as Junior Residents will be allowed to join as Junior Residents, if fresh graduates are not available.
- H. **Candidate must have not completed one year Junior Residency from any Govt. Hospital. (\*)**
- (\*) **Second List:** Junior Residents who have completed one year of Junior Residency shall also be allowed to appear in the Interview and will be offered residency only if fresh Junior Residents are not available. There would be no extension for any Junior Resident beyond one year of appointment under relaxed provision.



3. **CONDITION FOR RECRUITMENT:**

- A. All the eligible candidates should report in the office of the undersigned at 9.30 AM. [Time for enrollment from 9.30 A.M. to 11.00 A.M. only] on the day of interview.
- B. For candidates applying for OBC category, the certificate must be issued by the Competent Authority of Govt. of NCT of Delhi. Persons with disabilities shall be given relaxation as per rule.
- C. The number of vacancies may vary.
- D. No TA/DA will be given for appearing in the interview.
- E. Hostel accommodation is compulsory for Junior Residents.
- F. Candidate must submit their Bio-data with attested photocopy of certificates and original documents should be shown at the time of interview.
- G. Candidates are advised to ensure that they fulfill the eligibility criteria as mentioned in the advertisement before appearing the interview.
- H. Other service conditions will be applicable as per service conditions prescribed from time-to-time by the Govt. of NCT of Delhi.
- I. Candidate who is already in Govt. Service should submit **No Objection Certificate** from the employer at the time of interview.
