Application forms can be obtained from the Administration Branch of the hospital on date of interview. Candidates are required to submit the duly filled in application form along with copies of certificates and testimonials (duly self attested) and one passport size photograph at the time of interview. The candidates should report for interview at 9.00 a.m. in the Administrative Block (5th Floor), Jag Pravesh Chandra Hospital for the vacancies mentioned below:-

- . One post is reserved for Physically Handicapped person as horizontal reservation of SR.
- In OBC candidate, the OBC certificate must be issued from Delhi.
- . If candidate of reserved category is not available then the UR category candidate will be considered.

<u>Qualification:</u> MBBS with P.G. Degree/Diploma/DNB in the concerned specialty from a recognized University / Institution and should have a valid registration with Delhi Medical Council. Must have not completed 03 years Senior Residency in any recognized institution including regular & adhoc period.

Note: - In case of non-availability of candidate with PG Degree/Diploma, candidate with two years experience during PG Degree/Diploma in the respective specialty will be considered.

Pay scale: Rs. 67700 – 208700 of level 11 plus allowances as admissible under the rules.

Age: 40 years for Gen 45 years for SC/ST and 43 years for OBC candidates on the closing date of submission of application.

Note: - Further, in case of non availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of the relaxation of provision circulated as per circular No.F.121/26/2010/H&FW/1996-2045 dated 10/6/2011 of Deptt. of H&FW, GNCT of Delhi with the following relaxations:-

- i) Upper age limit for eligibility under relaxation will be 40 years.
- (ii) In the specialties where there is perpetual shortage like anesthesia and radiology etc. or in specialties where no fresh candidates are available, candidates who have completed 3 years of Sr. Residency may also be allowed to appear in the interview.
- (iii) Separate merit lists for fresh candidates and for others (those who have completed 3 years of Sr. Residency already) would be prepared.
- (iv) Firstly, the list containing the names of fresh candidates would be exhausted for appointment as Senior Residents and the second list would be used only after that.

Tenure: All Senior Residents appointment will be for 89 days only initially.

There would be no extension for any Junior Resident beyond one year of appointment under relaxed provisions.
