- 1. All Complaints and representations shall be received by the Committee online as well as offline mode at Nursing Home Cell, DGHS
- 2. The Committee would meet atleast twice a week either physically or through VC at a fixed time.
- 3. The Committee will be empowered to seek any documents from the concerned hospital including records of oxygen supply, storage & stock position.
- 4. The Committee will check whether the oxygen was being used properly in the hospital as per the norms
- 5. The Committee will check about the steps taken by the hospital for maintaining sufficient oxygen stock w.r.t the patients admitted therein.
- 6. The Committee would draw up a objective criteria to award compensation, limited to a maximum of Rs. 5 lacs in each case.
- 7. The Committee will firstly call for documents and records, examine them and pass a reasoned order only after calling for explanation from the Hospital/Nursing Home.

8. The Committee will undertake only a fact finding exercise and no fault shall be attributed to the Nursing Home/Hospital

The Committee will remain functional till further orders and will submit a report to the Addl. Chief. Secretary(H&FW), GNCTD on weekly basis.
