## 2. ELIGIBILITY CRITERIA FOR THE POST OF SENIOR RESIDENTS -

### A. Qualification:-

(1). MBBS with Post Graduate Degree/ DNB/ Diploma or equivalent as per residency scheme in concerned specialty from a recognized University/ Institution.

(2). In the condition, if candidates having P.G. degree/DNB/Diploma are not available, those without P.G. qualification but having 02 years experience in concerned speciality

B. Age :- Below 33 years, On Date of Interview, shall be for General candidates. 5 years relaxation for SC/ST and 3 years relaxation for OBC candidate.(OBC belonging to delhi only). Person with disabilities shall be given relaxation as per Govt. of India rules.

C. Pay:- Basic of RS. 67700/- in pay Matrix 11 of 7th CPC with other allowances as admissible per month.
