ORDER

A Committee comprising of the following Officers is hereby constituted under the Chairmanship of Sh. Satya Gopal, IAS, ACS(Power)/Nodal Officer (COVID) for preparing the Third wave Action plan for augmenting the Health Infrastructure Component.

The Committee shall also be empowered to co-opt additional members for implementing its mandate. Dr. Ashish Chandra Verma, IAS, Pr. Secretary (H&FW) and Shri Sanjeev Khirwar, IAS, Divisional Commissioner cum Pr. Secretary (Revenue), are co-opted as permanent members. The Nodal Officers will assess and provide crucial inputs in to the various nuances of operation of the verticals of Health Infrastructure being dealt by them and devise a coordination mechanism for the smooth operation between them. The Committee will assess the present status and projected requirement of the different vertical of health infrastructure like hospitals, oxygen plants, drug supplies etc and prepare an action plan for the Third Wave interalia including the following points:-



1. Preparation of Detailed plan of action to estimate the number of beds (isolation, oxygen, ICU, etc) required in the city, additional equipment required, where these equipment and materials will be sourced from (identification of temporary/ permanent sourcing). Additionally, an equitable geographical distribution of these facilities must be ensured so that these resources are spread across the city. Locations for temporary facilities, COVID Care Centres, field hospitals to be identified in advance so that they can be activated at high speed
2. **Supply Chain Management of crucial services and items** especially oxygen and critical drugs such as Tocilizumab and Remdesivir.
3. Identify other crucial components (equipment, drugs or any other item) which may create a bottleneck, and prepare supply chain management plans for them as well.
4. Ensure that all the large hospital facilities wherever possible must have their own oxygen generation plants which can serve their oxygen needs.
5. All Delhi Government hospitals must have provision for supply of piped oxygen for all their oxygen beds, adequate numbers of cylinders, concentrators and any other associated equipment.
6. An assessment of the requirement of appropriate transportation vehicles in order to procure cryogenic tankers, and other vehicles required for the smooth transportation of oxygen from other states of India.
7. Ensure that the procurement is done in a timely manner of the proposed vehicles.
8. Assessment of storage facilities for oxygen across the city and prepare a proposal for augmenting the required storage facility based on the expected surge in cases and requirement of oxygen followed by procurement and installation of storage to be done in a timely manner.
9. Procurement of all supplies and equipment and ensured that the stockpiles are maintained and the healthcare system is ready for the upcoming challenge.
10. Engagement/ empanelment of Additional specialized manpower at various locations so that activation of hospital infrastructure can be done within short timeframes.
11. Creation of a cadre of 10,000 trained Paramedical Volunteers to be created, along the lines of Civil Defence Volunteers. This cadre must be developed in collaboration with medical training organizations/ Universities/ disaster management experts, etc. who will be available to be deployed at short notice at different parts of the city. They can then be deployed in COVID Care centres, field hospitals, for support for patients in Home Isolation and multiple other roles that are required during a pandemic.



12. Ensure all Delhi Govt. Hospitals which are under construction at present, to be ready for operation with hiring of complete staff, installation of equipment etc so that they can be used as ICU facilities for referral of critical patients.


