ELIGIBILITY for Senior Residents:-

- 1) **Qualification:-** Post Graduate Degree (MD/MS/DNB/DIPLOMA equivalent) in concerned specialty. In Case of non availability of MD/MS/DNB/DIPLOMA Candidates, then Candidates who have at least 02 years Experience in the concerned specialty will be considered for the post and will be appointed on purely Adhoc basis for 89 days.
- 2) **Age Limit:-** For S.R. -45 years for General, 50 years for SC/ST and 48 years for OBC (Delhi) Candidates (as on date of interview)..
- 3) **Basic of Rs. 67700/-** in Revised Pay Matrix 11 of 7th CPC & other allowances as admissible.
- 4) No separate letter for interview will be issued. No TA/DA will be paid for appearing in interview.
- 5) Candidates must bring Original Certificates & submit their Application along with self attested copies of certificate at the time of interview.
- 6) The candidates who have completed three years Senior Residency but are willing to serve as Senior Resident can also apply and will be offered residency only if no fresh Senior Residents are available. However, their appointment will be for a period of 89 days extendable up to a maximum period of one year only.


