Notice for walk in interview for the post of Junior Resident on regular basis and on adhoc basis

A walk in interview for appointment for the post of Junior Resident on regular basis for a period of one year from date of joining in which you will be offered initially for a period of 6 months and it may be extended further period of 6 month on regular basis subject to the satisfactory work and conduct.. In addition 02 post of Junior Residents shall be filled on adhoc basis against the vacant post of GDMOs initially for a period of 89 days or till the joining of GDMOs whichever is earlier extendable upto maximum of one year on the basis of satisfactory work & conduct report from the concerned HOD on request from the doctor concerned. The walk in interview will be held in the Administrative Block of this hospital on 10th January 2022 (Monday) between 10.00 A.M. to 12.00 Noon

All eligible candidates who are interested for the same are requested to appear for the Walk-in-Interview on the scheduled date and time with self-attested copies of testimonials and one recent passport size photograph. Original certificates/documents are also required at the time of interview for verification.

ELIGIBILITY CRITERIA FOR THE POST OF JUNIOR RESIDENT [MBBS]

- (1) (Fresh Candidate):-
- (i) Qualifications:-MBBS degree from recognized University/Institute.
- (ii) <u>Age Limit</u>-As on 10.01.2022 shall be 30 years for General candidates, 35 years in case of SC/ST and 33 years in case of OBC candidates (OBC certificate issued from Delhi only).
- (iii)<u>Internship</u>:-Candidates must have completed their internship on or before 10/01/2022 and the candidates having completed compulsory rotatory internship before 10/01/2020 shall not be eligible.
- (2) Relaxation of Criteria: In accordance with circular No. F.No.121/26/2010/H&FW/1996-2045, dated 10.06.2011 issued by Health & Family Welfare Department, Govt. of NCT of Delhi, the following relaxation shall be applicable in case of non -availability of fresh candidates:
 - i). Upper age limit for eligibility will be 40 yrs, in place of existing 30 yrs of age.

- ii).PG Doctors who are interested to serve as Junior Residents will be allowed to join as Junior residents, if fresh graduates are not available.
- iii). Junior residents who have completed one year of junior residency may be allowed to again appear for interview for selection and will be offered residency only if no fresh junior residents are available. There would be no extension for any junior resident beyond one year of appointment under relaxed provision.
- 3. Pay Scale:-Pay Matrix 10 of 7th CPC with Basic Pay of Rs. 56100 and other admissible allowances per month.
- 4. Must be registered with Delhi Medical Council.
- 5. Appointment will be initially for a period of 6 months extendable up to maximum of one year on the basis of satisfactory work & conduct report from the concerned HOD on request from the doctor concerned. For Junior Resident on adhoc basis against the vacant post of GDMOs appointment will be initially for a period of 89 days or till the joining of GDMOs whichever is earlier extendable upto maximum of one year on the basis of satisfactory work & conduct report from the concerned HOD on request from the doctor concerned.
- Appointment will be subject to medical fitness and verification of certificates of educational qualification/age/caste/DMC registration and internship completion certificate etc.
- 7. There is no fee for appearing in the Interview.
- 8. Reservation for PH candidates shall be as per rules of Govt. of India.
- 9. In case, SC/ST/OBC candidates are not available for JR, the post shall be filled for 89 days(or till regular candidate joins, whichever is earlier) on adhoc basis from available candidates and vice versa.
- 10. Panel of waitlisted candidates will be prepared for filling the post of JR for vacancies arising in future.

 The panel shall remain valid for 6 months or till fresh selection process is carried out, whichever is earlier.
- 11. No. of vacant posts may vary.
- 12.Medical Superintendent being HOD of the institution shall reserve rights to make any changes in the schedule/selection process in public interest.
- 13. The decision of the Medical Superintendent shall be final under all circumstances.
